The Saddle Fitter Small Tour award: highest average percentage gained over the Intermediate I CDN & the Intermediate Freestyle CDN – Prize rug for winner, 1st - \$500, 2nd - \$300, 3rd - \$150.

Each team to be composed of three different horse & rider combinations riding one of the following:

- Advanced 5.3 (Comp 18)
- Prix St Georges (Comp 7)
- Intermediate 1 (Comp 8)

Comp 32: State of Origin Medium & Big Tour Team

Each team to be composed of three different horse & rider combinations riding one of the following:

- Intermediate B (Comp 11)
- Intermediate II (Comp 13)
- Grand Prix CDI (Comp 1)

Comp 33: State of Origin Young Rider Team

Each team to be composed of three different horse & rider combinations riding in each of the following:

- FEI Young Rider Team Test CDI-Y (Comp 4)
- FEI Young Rider Individual Test CDI-Y (Comp5)
- FEI Young Rider Freestyle CDI-Y (Comp 6)

- Team entry fee is NIL.
- Rosettes to 3rd place.
- Scores (percentages) of team members are added together to determine the team's score.
- Each team is composed of 3 different riders from the same state. One rider may be in more than one team riding different horses.
- Each state may enter more than one team per competition.
- State team entries must be made by the appropriate state branch in writing (email), one week after the acceptance list is first published.
- No changes to teams are permitted once competition commences on 14 July, 2016.

Conditions of Entry

CDI-3* GP and CDI-Y Competitions – will be held in accordance with current **FEI Statutes, General Regulations, Veterinary Regulations and Dressage Rules**.

National Competitions – will be held in accordance with the current EA Dressage Competition Rules & Procedures and EA General Regulations.

MEMBERSHIP & HORSE REGISTRATION

- ALL Horses, owners and riders must be **registered and financial with EA** or, if from overseas, with their National Federation. Horses must compete under their full registered name. The Organising Committee has the right to abbreviate a horse's name for printing purposes. EA Membership numbers **must** be shown on the Entry Form.
- Horses must have a current EA Dressage competition license (performance card).
- **CDI-3* GP & CDI-Y:** Riders may participate **only** under the **jurisdiction of the country with which they hold their passport**.
- **Horses taking part in the CDI3* GP** must have a current FEI Passport or Official FEI recognised EA Identification Document.
- **Horses taking part in the CDI-Y-** FEI Passports are not required, an EA National ID Document or EA Horse registration papers are required. Riders must ensure that they have the appropriate documents on arrival. Enquiries to Equestrian Australia 02 8762 7777.
- All riders and horses participating in FEI events (CDI3* GP; & CDI-Y) **must be registered on the FEI database. Registrations must be renewed each calendar year (i.e. Jan 1 2016)**. EA collects the charges on behalf of the FEI. Registration forms are available on the EA web site. www.equestrian.org.au or contact the National Office 02 8762 7777. Please note that this registration is required even if the horse has an FEI Passport or EA National Identification Document. All horses and riders must be registered with the FEI BEFORE competing in any FEI sanctioned events (CDIs) in 2016.

ENTRIES & PERFORMANCE

- **Rider Age: CDI3*** – is open to riders from the year in which they reach their **16th birthday**. **CDI-Y:** Open to riders from beginning of the calendar year in which they reach the age of **16** until the end of the calendar year they reach the age of **21**.
- **National Competitions:** entry of horses is limited to **two consecutive levels**, e.g. Advanced/Prix St Georges; Prix St Georges/Intermediate I.
- CDI entries: horses may take part in **one test per day** (FEI Dressage Rules, Art. 422) and may not start in a national competition until the day after completing their last international competition.
- **National competitions**, as per EA current rules.
- **Eligibility & Performance:**
 - All qualifying performances must be from Official Competitive competitions. The qualifying period **5 June 2015 to 5 June 2016**. Please submit your 3 x best performances attained during the qualifying period.
 - **CDI3* Grand Prix:** At least two performances of 62% or higher at Grand Prix (not including GP Special or Freestyle)
 - **CDI-Y:** At least one performance of 60% at PSG level (CDI-Y Individual or Team test performances accepted)
 - **Advanced, Prix St Georges & Intermediate I:** At least one performance of 60% at the level entered
 - **Intermediate II, Intermediate A/B; Grand Prix CDN:** At least one score of 60% at the level entered
 - **Young Horses & Ponies:** At least one performance of **6.5** or more in a Young Horse or Pony Qualifier in their age group. Other performance under exceptional circumstances may be accepted at the discretion of the OC.
 - **Para-Equestrian:** There is **no** performance requirement for PE competitions (refer to conditions on Page 9).
 - **Saddleworld Novice Team Club Challenge** (refer to conditions on Page 9)
 - Entries will be accepted on merit **or** at the discretion of the Organising Committee
- At least one qualifying score to be obtained by the nominated horse/rider combination. The OC will consider exceptions in special circumstances only.
- The **number of horses per rider per competition** may be limited.
- One HC performance is permitted
- The Organising Committee reserves the right to allocate 'wildcard entries' at each level in exceptional circumstances for national competitions only. **Wild cards are not an option for CDI competitions.**
- Horses entered for all competitions (except the Young Pony classes), must have a height at the withers **exceeding 149cms** including shoes.
- **Horse Age:** Horses must be at least 7 years of age for PSG, Int I & CDI-Y, for tests above Inter I horses must be a minimum of 8 years of age. CDI-Y: Horses must be at least 7 years of age.
- **Entry Fees:** Refer page 3.
- **CDI3* GP** riders may enter both the GP Special and the GP Freestyle or they can opt to ride only one. Horses must qualify with a score of 60% in the GP to be eligible to ride in the GP Special or the GP Freestyle.
- **Horses** entered in the **CDI-Y** must enter all three competitions at that level.

CDI3* GP & CDI-Y HORSE INSPECTIONS & VETERINARY EXAMINATION

- **Horse Registration Control and Veterinary Examination and Inspection all horses:** These will be carried out in accordance with current Veterinary Regulations and General Regulations and Rules for Dressage Events. Horse Registration control and **veterinary examination** will take place Thursday, 14th July 2016, time to be advised with acceptance list. The fitness inspection ("**trot up**") will take place on **Thursday, 14th July**, at approx **4.30pm**. Details will be provided with the acceptance list. All horses entered in the CDI3* GP & CDI-Y are required to trot-up.
- **Sampling procedure for Prohibited substances** – Vet Regs, Chapter V & VI and Annex III. Horses will be subject to sampling for Prohibited Substances.
- **Insurance:** All owners and competitors are personally responsible for damages to third parties caused by themselves, their employees, their agents or their horses. They are therefore strongly advised to take out a third-party insurance providing full coverage for participation in equestrian events at home and abroad, and to keep the policy up to date.
- **Veterinary & Farrier:** Services will be available on call. Contact details will be provided with the acceptance list.

OBJECTIONS & APPEALS:

- **CDI** competitions Refer FEI Gen. Regs Art. 163, 165, 166 & 167. Must be in writing and accompanied by a deposit of 150 CHF (approx. \$220 AUD).
- **National** competitions must be in writing and accompanied by a fee of \$100.00. Attention is drawn to Rule 1.5 of EA Dressage Rules.

DECLARATION OF STARTERS (CDI3* GP & CDI-Y)

- Refer FEI Dressage Rules, Art 424
- CDI3* GP & CDI-Y: Declaration of starters: must be done by midday for the following day's competitions. Riders who have not declared by midday will be considered as a starter for the competitions entered at the closing date of entries.

TIME DRAWS

- CDI3* GP & CDI-Y Friday competitions the draw will take place as soon as possible after the Fitness Inspection on Thursday 14th July and will be placed on the Notice Board and also published to the web site.
- The draw for National competitions & Young Horse first Round will be a normal draw and will be available at www.qld.equestrian.org.au/dressage/brisbane-cdi

WITHDRAWALS & REFUNDS

- Refer EA rule 8.4: **Withdrawals must be notified to the OC** as soon as possible. Withdrawals at the event must complete a withdrawal form available at the Event Office.
- **Refunds:** Entry fees will not be refunded after the closing date of entries unless a medical or veterinary certificate is produced **within 24 hours** of the completion of the event. In such cases, 50% of the entry fees will be retained by the O.C. Entry fees will be refunded in full as soon as possible for withdrawals before the closing date. Entry fees for riders on the reserve list who are not offered a start in a competition will be refunded after the event.
- **The administration fee will not be refunded under any circumstance.**

SADDLERY & EQUIPMENT

- **Bridle numbers (Identification number)** must be worn at all times when the horse is outside its stable. Please include your allocated bridle number on the entry form. In the case of duplication of numbers, the OC will allocate a temporary # for this event only. Failure to display identification numbers may incur a warning or in the case of a repeated offence, a fine imposed by the Ground Jury.
- **Whips: CDI3* GP & CDI-Y:** It is, under penalty of elimination, forbidden to carry a whip of any kind while competing. However, the use of one whip, with a total maximum length of **120 cm**, in the practice area is allowed. **The whip must be dropped before entering the space around the competition arena or the athlete will be penalised (FEI Dressage Rules, Art. 428.3 & 430).** Only riders, or grooms when riding, walking or lunging a horse, are allowed to carry a whip on the show grounds.
- **National competitions: Whips** that do not comply with current EA rules (e.g. must not exceed 120cm in entirety for horses, 100cm for ponies), will not be allowed in the **warm-up** and **competition** areas. **A whip may be carried in all National competitions. Young Horse & Pony** a whip may **not** be carried in 5 & 6 YO competitions.
- **Hats and head wear:** As per current EA or FEI rules (FEI Dressage Rules, Art 427).
- **Protective headgear:** Riders aged 21 years and under must wear protective headgear at all times, including during the Fitness Inspection. Riders who are 22 years and older and who are riding horse that are seven (7) years and older may wear a top hat instead of protective headgear. Protective headgear is recommended to be worn by all riders at the Fitness Inspection.
- **Advertising and Publicity** on competitors and horses (FEI Gen. Regs. Art. 135)
- **Fly Hoods:** EA rules apply for National competitions; FEI rules apply for CDI3* and CDI-Y competitions. Refer EA/FEI rules for details.

FREESTYLES & GRAND PRIX SPECIAL

- **Advanced Freestyle:** The top 12 placegetters in the **Advanced 5.2 & 5.3** qualify to ride the Advanced Freestyle (if entered), points will be awarded as per EA National Championship rules to determine ranking.
- **Intermediate Freestyle:** The top 12-15 placegetters in the Intermediate I qualify to ride the Intermediate Freestyle but a horse must earn a minimum score of **60%** in the qualifying competition (Inter I) to be eligible. The Organising Committee is free to invite the best in the Prix St Georges to make up numbers.
- **CDI3* Grand Prix Freestyle:** the top 15 placegetters in the CDI3* Grand Prix qualify but a horse must earn a minimum average score of **60%** in the CDI3*GP to qualify.
- **CDI3* Grand Prix Special** (same conditions for CDI3* Grand Prix Freestyle).
- **EA/FEI Medium Tour Freestyle:** The top 6-8 placegetters in the Intermediate B who have scored **60%** or more will be eligible.
- **CDN Grand Prix Freestyle:** The top 5-6 placegetters in the CDN Grand Prix qualify but a horse must earn a minimum average score of **58%** to qualify. Horses that do not qualify to compete in the CDI3* Freestyle will be permitted to compete in the CDN at the discretion of the OC & the Ground Jury if **58%** or more has been gained (there will be separate rosettes only awarded).
- **CDN Grand Prix Special** (same conditions for CDN Grand Prix Freestyle).
- **CDI-Y Freestyle:** Limited to the top 18 combinations from the Young Rider Individual competition who must earn a minimum score of **60%** in the CDI-Y Individual competition to be eligible.
- Freestyle Music on CD only to be handed in to the Event Office in the Riders Marquee, there will be a timetable for Freestyle music testing.

PRESENTATIONS

- **Presentations** will be **unmounted** except for the CDI-Y Freestyle, Intermediate Freestyle, CDI3* Grand Prix Freestyle, Medium Tour Freestyle, Advanced Freestyle, Champion QLD Young Horses & Ponies, & Sharon Doe - these will be **mounted**.
- Participation in prize-giving ceremonies is **compulsory**. Failure to do so entails losing the classification (sash, prize in kind, prize money FEI Dressage Rules Art.436).
- **Prize money**. Will be processed within approx. 14 working days post the event. Any outstanding debts will be deducted from prize money. (FEI Gen.Reggs, Art. 128): **Prize money** is awarded to the **owners or lessees** of horses. Competitors **must** provide Bank Account details so that funds can be transferred into the nominated bank account.

ACCREDITATION

1 rider, 1 groom per horse and 1 owner per horse will gain accreditation to the event. Please collect from the **CDI Riders Marquee** outside the indoor. This pass allows daily access to the venue and stables.

STABLING

- **CDI3* GP & CDI-Y** International Rules require horses to remain on the competition grounds for the duration of the event (*from the "trot-up" until the horse has finished competing*). This rule does not apply to horses taking part in National competitions.
- **All horses competing at the QSEC Indoor Complex must hire a stable. Day parking (tying to float/truck) is not permitted at this event.**
- Excellent stables are available on the grounds, 3.6m x 3.6m with anti-slip rubber matting and bitumen isles. 1/3 cubic metre (6-7 wheelbarrows) of shavings is included in the stable hire fee of **\$27.00 PER DAY** (eg. if arriving Thursday and departing Friday this is 2 days of stabling). Stables will be pre-filled. More bedding can be ordered from the venue's contracted supplier – details will be provided in the Competitor Information Pack.
- All stallions are to be stabled. EA Stallion safe guidelines apply at this event.
- A stable allocation will apply and no horses are to be moved without permission from the Stable Manager.
- All horses staying overnight must be stabled.
- There is a compulsory stable bond of **\$50.00** per stable and tack room. If stables and tack rooms are not left swept clean of all bedding, manure, urine and other waste, this bond will be retained. All stables must be inspected by the Stable Manager prior to departure for a "clean pass".
- **Competitors** are responsible for paying any damages incurred to stables during the event - **minimum fee \$200.00 or as determined by QSEC**.
- Private tack rooms will be allocated if sufficient spare stables are available. These must be booked with entries at **\$22 PER DAY**.
- **Day Parking** (tie to float) for those competing in competitions at Barr Oval is permitted or you can hire a day yard at **\$12 per day**. **Competitions at Barr Oval are Preliminary 1.2, Preliminary 1.3, Novice 2.1, Novice 2.2 & all Para Equestrian classes.**
- **Security** will be in place for the entire stable block from Thursday from 6pm-6am. There will be no access to non accredited persons.
- All competitors must complete a '**Horse Health Declaration Form**' before unloading horses at QSEC. A copy of this form can be found here <http://www.qsec.com.au/uploadedFiles/QSEC%20HORSE%20HEALTH%20DECLARATION%20FORM.pdf>
- **STABLE PROTOCOL: SMOKING is not permitted in the stables!** Prams, bicycles, scooters & golf buggies are not permitted in the stables (exception – vehicles used by Stable Manager & venue staff). Children must be supervised at all times. For safety reasons we recommend that all persons including children wear closed footwear whilst in the stables.

CAMPING & PARKING

Powered & Unpowered Camp sites are available with good amenities available and must be booked at time of entry. Cost is **\$25 PER NIGHT** for powered sites and **\$20 PER NIGHT** for unpowered sites.

ACCOMMODATION in the area visit the Morton Bay Council website (we suggest you book early) <http://www.moretonbay.qld.gov.au/guide.aspx?display=accommodation>.

CATERING: Catering will be available on the grounds from Breakfast on Thursday morning.

CALLERS: are not permitted (except for the 4YO 5YO and 6YO first round which are commanded tests. The preliminary and novice tests may have callers).

DOGS: Dogs are permitted in QSEC camping grounds provided they are kept on a lead (maximum length of 1 metre) and under control at all times. Dogs must be kept away from horse activities including the Main Arena and shower/ toilet/laundry facilities. Any person not adhering to this guideline will be asked to leave the grounds immediately and no refund given. Please ensure that dog droppings are disposed of using the bags provided. Do not bring dangerous dogs to this event.

Indemnity: Neither the Organising Committee (Dressage QLD), their appointed officials, Equestrian Australia or QSEC accept any liability for any accident, theft or illness to horses, riders, grooms or any person or property whatsoever. All competitors, in entering, undertake to accept this regulation.

VACCINATIONS

There are no vaccination requirements to enter this event. However we strongly encourage owners of horses that reside in high risk areas to vaccinate against the Hendra Virus. Riders are required to advise the Hendra vaccination status of their horses on the entry form. We recommend that horse vaccinations for Strangles and Tetanus are up to date.

QUEENSLAND TICK REQUIREMENTS: Please contact **QLD DPI Call Centre:** Ph. (07) 3404 6999 for information (allow 24 hrs notice). Spraying arrangements for horses returning to tick free areas and NSW are currently being investigated so as to allow horses to be sprayed at QSEC prior to departure.

PROPERTY IDENTIFICATION CODE: It is compulsory to provide a PIC with your entry.

QSEC Policy: Please note QSEC has a **no glass** policy. Only alcohol purchased at the venue can be consumed at the Indoor complex.

ADDITIONAL CONDITIONS OF ENTRY

Conditions of Entry QLD State Young Dressage Horse & Pony Championships

Thursday, 14th July (Outdoor grass arena)

Competitions 20 to 25: **Round 1** ridden in groups of two (see below for tests to be ridden)

Friday, 15th July (Outdoor grass arena)

Competitions 20B to 25B: **Round 2** The Top 10 placed horses from Round 1 who score a minimum of 6.5 (see below for tests to be ridden): The **winner** of each age group in round 2 will be named the QLD State Young Dressage Horse or Pony Champion for their respective age group.

- Refer Section 5 of the EA dressage rules for full details. All horses, riders and owners must be current members and registered with the EA. EA Rules apply. All horses must exceed 149cms with shoes.
- The birth dates for all horses and ponies will be as at 1st August. e.g.
 - 4 YO: for horses and ponies born between 1/8/2011 and 31/7/2012
 - 5 YO: for horses and ponies born between 1/8/2010 and 31/7/2011
 - 6 YO: for horses and ponies born between 1/8/2009 and 31/7/2010
- All horses are to be ridden in a snaffle bridle (min. diameter of mouthpiece is **14mm** for horses, **10mm** for ponies), Mexican/crossed noseband not permitted. Refer Section 2 of the rules for more details on saddlery.
- **Whips** are permitted in the 4YO competitions only – max length 1.2m for horses, 1m for ponies.
- **Approved safety helmets are to be worn for all Young Horse Competitions**
- Horses will be judged on walk, trot, canter, rideability and overall impression.
- There will be two (2) rounds – **Round 1** will be commanded and ridden in groups of 2.
- **Round 1:** EA YH commanded tests for 4,5 & 6 YO horses, EA YH commanded tests for 4 & 5 YO ponies, EA YP commanded test for 6 YO ponies. **Round 2:** Tests to be ridden will be: **4 YEAR OLD Horses & Ponies:** FEI test for 4 year old horses, **5 YEAR OLD Horses & Ponies:** FEI YH Preliminary test for 5 year old horses; **6 YEAR OLD Horses:** FEI YH Preliminary test for 6 year old horses, **6 YEAR OLD Ponies:** EA Young Dressage Pony – 6 year old.
- Tests for **State Championships** can be downloaded from the EA web site www.equestrian.org.au/dressage-YH
- Scores from the First Round **do not** carry forward to the Second/Final Round.
- Winners of Round 2 for 4, 5 and 6 YO will be named Queensland Young Horse or Pony Champion for their age group
- **Prizes: Championship rug for winners of Round 2;** Prizes/money & rosettes for Round 2 (see page 2). **Entry Fee:** \$88 per horse. (This covers all rounds).

Performance

- All entries must be qualified by having achieved:
 - Preference will be given to those that have achieved **6.5** or more in a Young Horse or Pony qualifier at the age entered during the qualifying period **5 June 2015 to 5 June 2016**. If over subscribed, horses and ponies with more than one result may have preference over horses and ponies with only one result.

Young Horse Masterclass with Lilo Fore (FEI International and Young Horse 5* Judge) – Saturday, 16 July 2016

- The top 3 Young Horse placegetters in Round 2 of the 4 YO, 5 YO & 6 YO championships are invited to take part in a masterclass with FEI International and Young Horse 5* judge, Lilo Fore.

Conditions of Entry – Advanced

The **Advanced** will consist of two competitions at Advanced level (5.2 & 5.3) with the top 12 combinations who entered the freestyle going forward into the Advanced Freestyle. Points will be awarded as per National EA championship rules in the 5.2 & 5.3. The winner of the Advanced Freestyle will be the overall winner.

Conditions of entry:

- At least one performance of 60% or more in an Advanced test during the period 5 June 2015 to 5 June 2016.
- One HC result is permitted
- EA conditions apply. Whips are permitted.
- Entry fees will be refunded for those who enter and do not qualify for the Freestyle.

Conditions of Entry – Inter A/B, Inter 2, Grand Prix CDN, GP CDN Freestyle & GP Special CDN

- At least one performance of 60% at the level entered or higher during the period 5 June 2015 to 5 June 2016.
- A score of at least 58% or more in the GP CDN and at least 60% in the Inter B to take part in the relative Freestyle competition depending on time constraints a maximum of 6-8 horses will be accepted in each freestyle.
- A score of at least 58% or more in the GP CDN to take part in the GP Special CDN.
- EA conditions apply: **Whips** are permitted.
- Entry fees will be refunded for those who enter and do not qualify for the Freestyle or GP Special.
- **Grand Prix CDN, Inter 2 or Inter A/B horses are not subjected to a Fitness Inspection**

Conditions of Entry – Prix St Georges, Intermediate I & Intermediate Freestyle

- At least one performance of 60% or more at the level entered during the period 5 June 2015 to 5 June 2016.
- The top 12-15 placed competitors (dependent on time constraints) with a minimum score of 60% in the Intermediate I who entered the freestyle will go forward to the Intermediate Freestyle at the discretion of the OC. The OC may consider the top combinations in the Prix St Georges if insufficient numbers qualify in the Intermediate I competition.
- EA conditions apply. Whips **are** permitted.
- Entry fees will be refunded for those who enter and do not qualify for the Freestyle.

Conditions of Entry – Para-Equestrian

Two competitions are offered for Para-Equestrian competitors:

- The FEI Team and FEI Championships tests.
- FEI Team test to be held on Saturday 16th July, FEI Championships tests to be held on Sunday 17th July. The competitions will be conducted at Barr Oval (QSEC outdoor complex).
- Tests will be judged by EA Para-Equestrian judges.
- Performance is not required to qualify for this event.
- Every effort will be made to accommodate the requirements of Para-Equestrian riders, but due to the nature of this event it may not always be possible. Competitors competing over several days will have preference over other competitors.
- Para-Equestrian competition rules apply as per the current EA rule book, Section 9.
- The organising committee reserves the right to cancel Para-Equestrian competitions if insufficient entries are received, that is, less than 2 entries per competition.

Saddleworld Novice Club Team Challenge

- The Brisbane CDI has invited clubs to participate in the 2016 Brisbane CDI
- SADDLEWORLD will present a PDS Grande – Carl Hester Collection saddle to one lucky club who has a team of two riders competing in the Novice Club Team Challenge on July 16 and 17 at QSEC, Caboolture. One lucky club will be drawn from all those that have a team competing in **both** the 2.1 and 2.2 competitions being held at Barr Oval (QSEC Outdoor Complex).
- Each club can enter a team of two riders selected by the club. Minimum entry requirement is 63% in a Novice test, gained in an official or participation competition from Jan 1, 2016 to the closing date 5th June 2016 at a designated SADDLEWORLD Novice Club Team Challenge Qualifier.
- Other club and other EQ members may enter as individuals. Club team members will take precedence over individual entries.
- **Riders** must enter, **online via Nominate by June 5**. Please note your club when entering. An acceptance list will be prepared as soon as club teams are finalised. (The team of two riders per club will have a guaranteed acceptance of entries.) We also hope to be able to accept all individual riders' entries.
- The competitions will be "participation" & will not attract grading points. Riders must be an EA competitor or participation members. Horses need not necessarily be EA registered. Clubs must be affiliated clubs with Equestrian Qld.
- **Rosettes** will be awarded to all competitors in the Novice 2.1, the top 10 placegetters in the Novice 2.2, and the 1st to 3rd placed teams in the Saddleworld Novice Club Team Challenge. The perpetual Saddleworld Novice Club Team Challenge trophy will be awarded to the winning team.

Conditions of Entry – Preliminary 1.2 & 1.3

- Minimum entry requirement is 65% in a Preliminary test gained in an official or participant competition from 5 June, 2015 to the closing date 5 June, 2016.
- These competitions are "Participation" and will not attract grading points.
- Riders must be an EA competitor or participation member. Horses need not necessarily be EA registered.
- The purpose of these competitions is to allow riders in the Saddleworld Novice Club Team Challenge to be more a part of the CDI and as consolation classes for young horses and ponies who do not make round 2.

The Sharon Doe Memorial Rider's Trophy for Riders under 25

Background

Sharon Doe was a highly successful young Queensland dressage rider, who competed in and won numerous dressage championships up to and including FEI level.

The Sharon Doe Memorial Rider's Trophy was donated by Marion and Edgar Lichtwark in memory of Sharon Doe, who was a rider who simply loved to ride. It never mattered to Sharon what she rode, she just loved to be astride a horse. She always said she felt happiest when she was riding. All those who remember Sharon remember the lightness and harmony with which she rode her horses. The Sharon Doe Memorial Rider's Trophy event has been formatted along the lines of the European Riders Championship.

Guidelines for Entering

- This is a rider class, and is to be judged on the rider, not the horse.
- It is open to riders up to the age of 25yo (Entries will be accepted from other states)
- Horses and riders must both be registered with Equestrian Australia.
- Horses must be eligible to compete Prix St Georges (ie have achieved 2 scores of 60% or more at Official Advanced level) Riders will be required to perform movements up to Prix St Georges level, as determined by the judges on the day. The layout of the performance is to be choreographed by the rider, to best highlight their skills.

Prizes: Perpetual trophy, rug and keepsake trophy for the winner: Keepsake Rosette for all class entrants.

Entry Fee: \$55

Format of the Competition

Riders will meet with the judges one hour prior to the class. The judges will inform the riders of what movements they wish to see the riders perform. The riders are to go away and choreograph their test to best highlight their skills and capabilities. The time allowed for each test is approximately that of a regular Prix St Georges test. After the rider has finished their test, they will immediately meet with the judges, who will provide the rider with helpful and positive feedback on their performance. After addressing the rider, the judges will address the audience regarding the performance of the rider, bearing in mind the purpose of this class is to encourage young riders.

Welfare of the Horse

CODE OF CONDUCT

The Fédération Equestre Internationale (FEI) expects all those involved in international equestrian sport to adhere to the FEI's Code of Conduct and to acknowledge and accept that at all times the welfare of the horse must be paramount and must never be subordinated to competitive or commercial influences.

1. At all stages during the preparation and training of competition horses, welfare must take precedence over all other demands. This includes good horse management, training methods, farriery and tack, and transportation.
2. Horses and competitors must be fit, competent and in good health before they are allowed to compete. This encompasses medication use, surgical procedures that threaten welfare or safety, pregnancy in mares and the misuse of aids.
3. Events must not prejudice horse welfare. This involves paying careful attention to the competition areas, ground surfaces, weather conditions, stabling, site safety and fitness of the horse for onward travel after the event.
4. Every effort must be made to ensure that horses receive proper attention after they have competed and that they are treated humanely when their competition careers are over. This covers proper veterinary care, competition injuries, euthanasia and retirement.
5. **The FEI urges all involved with the sport to attain the highest levels of education in their areas of expertise.**
