EVENT AND VENUE DETAILS

 Dressage – Dressage arena will be 100m x 40m. A separate 100m x 40m warm up arena will also be available.

All Preliminary Classes: *ADS Preliminary Test 1 (1994)* All Intermediate Classes: *FEI 1*B (former Test 1)*

All Advanced Classes: FEI 2*A

- Cones This will be conducted as a fault competition and all of the cones will be measured.
 Preliminary classes 40cm allowance, Intermediate classes 30cm allowance, Advanced classes 22cm allowance.
- Marathon Classes 1-31 will compete over the complete marathon (three sections: A,Transfer, B). The total course of approximately 15 km will be clearly marked. All obstacles are located near the Dillmann's house and camping ground and can be inspected from 3:00pm Friday 18 April. The marathon includes some undulating country. There will be 6 Marathon Obstacles in Section B that are all purpose built.

^{*} The distance of the transfer section will be approx. 1km and time allowed in the transfer section to be confirmed. The transfer section speed required will be slow which gives you a chance to rest your horse prior to section B. There is a 10 minute compulsory rest at the end of the transfer section and a vet check prior to starting section B.

- Catering <u>Saturday Night</u>– Southbrook Pub (4km from Strongfield Stud)
 - Lunch (BBQ sausage sizzle) and drinks will be available on site on both days for a small fee.
 - -The kettle and BBQ will be available for competitors to use throughout the weekend.
- Camping and Facilities There is plenty of camping space at Strongfield Stud and there are toilets and hand basins in the camping grounds. Showers with warm water are also available for use on site.

 -240V power is also available near the camping grounds for charging phones etc.
- Yards— Competitors are welcome to bring their own yards. There are a number of day yards available for use. Competitors use yards at their own risk. Numbers are limited, so please indicate if you require the use of a yard on the entry form. There will be no extra fee for the use of yards.
- Water Bore water is available for use and there are taps located near the yards and stables. Bring your own water containers for your horses. There is a concrete wash bay with a hose for washing horses. Fresh tank water is also available for human drinking water only.
- **Dogs** Dogs are not permitted.
- Loading Ramp An earth loading ramp is located near the camping ground to load/unload carriages
 and horses if needed.







CONDITIONS OF ENTRY

This event will be conducted under the F.E.I. Rules for Driving Events as at 1st January 2015 with variations and additional regulations included in this schedule.

Drivers must be Warwick Club members or EA members. A restricted membership form for this event must be completed for drivers who are not Warwick Club members or EA members. Club Receipts or current Membership Cards (Club or EA) must be available for checking if required to receive Competitors Kits. As this is an unofficial event, horses are not required to be registered with EA.

All competitors and their navigators/grooms compete at their own risk. The organising committee and land holders accept no responsibility for loss or damage to horses, owners, passengers, equipment, drivers, grooms or spectators, or any other person or property whatsoever, whilst at or near the venue, during the course of this event. All competitors, by entering this event, agree to be bound by this regulation.

All child/junior drivers between 12 and 18 years must be accompanied by a capable groom 18 years or over in all phases of the competition. Whenever a child/junior is in a vehicle they must be wearing an equestrian type helmet that complies with one of the three standards below.

Carriage weight restrictions are not enforced at this event. Conflict of interest rules (article 984 point 3) are not enforced at this event.

Appeals, together with \$20, are to be lodged in writing within 30 minutes of the scores being posted for each phase. Money may be refunded unless, in the opinion of the Appeals Committee, the appeal is found to be frivolous.

The organisers reserve the right to:

- * Alter any advertised times;
- * Refuse any entry, with or without stating the reason;
- * Refuse admission to any person whose attendance may, in the opinion of the Organising Committee, impose a risk on the person, or to Warwick Club and EA members, or members of the public; or due to inappropriate behavior or failure to comply with the Club's and EA expected standard of behavior;
- * Measure any horse or pony upon discretion
- * Reallocate a competitor to the appropriate class

Entry fees must accompany nominations.

The event will be run on time. Any competitor late for a scheduled starting time will be awarded time penalties. In the event of an accident, or any other occurrence beyond the control of the competitor, contact the Secretary to arrange an alternate starting time.

Organisers reserve the right to penalize competitors for unsafe practices.

Back protectors are recommended for the marathon.

The wearing of equestrian helmets complying with one of the three standards listed below and on the entry form is mandatory in the marathon and medical arm bands are recommended.

Equestrian helmets standards

- 1. AS/NZS 3838,
- 2. European Standard EN1384,
- 3. United States Standard ASTN F1163

It is a condition of entry that competitors hand to the organisers a Horse Health Declaration Form before you receive your competitors kit.
