GENERAL INFORMATION

The Brisbane CDI Organising Committee would like to thank you for your entry and wish you the very best of luck at the event. Please read through the following important information regarding the Brisbane CDI. Regular updates will be posted on the CDI web page and on our Facebook page (search Brisbane CDI).

QSEC IS A GLASS FREE VENUE

As users of this great venue we need to observe and comply with the laws that the venue is run under, which are the same laws as other large sporting venues in Qld, such as Suncorp Stadium and the Gabba. If you bring glass onto the venue in your vehicles, then that's where it needs to remain – **DO NOT** place empty bottles in the QSEC rubbish bins – take them home with you. There are large fines for people who do not abide by these rules, and as these rules have been being flaunted by users of the venue, spot checks have started to be carried out.

FACILITIES

We request that competitors take the utmost care in looking after the wonderful facilities that are being provided at QSEC. Please take pride in this fantastic venue and keep the toilets and amenities block clean. Recycling bins are located throughout the venue and we request that you place your rubbish in the appropriate bin. Please make yourself familiar with the QSEC Camping & Stable Rules and Regulations:

The indoor arena precinct is a non BYO alcohol area – that is, you can only consume alcohol that has been purchased at the bar at the indoor arena.

DOGS

Dogs are permitted in the stable complex **ONLY**. Dogs **ARE NOT PERMITTED** at the indoor arena. All dogs at all times must be secured or on a leash that is no longer than 1 metre in length. **Do not bring dangerous dogs to this event.**

BIOSECURITY

New biosecurity legislation came into effect in Qld from July 1. The result of this is that we must all keep Movement Records when we take our horses somewhere. A Movement Record can take many forms – it can be a written note in a diary, a horse health declaration form, a note in your smart phone, etc. It needs to record the date of the horse movement, a description of the horse, the property of origin (including PIC), where you are going (including PIC), and who completed the record. You are required to keep these records for 2 years.

The Horse Health Declaration form that you will be required to submit on arrival at the Brisbane CDI can be your Movement Record, however, as we require you to submit your horse health dec to us, you will need to take a copy of the form, i.e. photo with your phone. You will also need to create a Movement Record for your trip home.

QSEC's PIC is QGCB1219.

SPRAYING FOR COMPETITORS FROM NSW OR TICK-FREE AREAS

We have arranged for an accredited stock inspector to come to the venue on Sunday July 17 at 1.30PM, to spray horses returning to NSW or Tick Free areas. The stock inspector will help you with the paperwork, as will the organising committee.

This will mean that you will not have to stop at a Treatment Facility, such as Kirra, on your way home. We hope that this will make your journey home to NSW much more stress free. The cost of spraying is being subsidised by the event, but you will be asked to pay **\$10 per horse**. Please have this money in cash at the time of spraying and give it to the organising committee member who is organising the spraying. Riders who are not from NSW but who are from tick free areas in Qld and would like to also have their horses sprayed at the venue, please notify me ASAP.

They are continually being updated as scratchings are received.

CDI competition draws for Friday's competition will take place on Thursday July 14 immediately following the Horse Fitness Inspection, then each day before scheduled competition.

A **final revised** draw may be necessary the day before each competition to allow for withdrawals. The starting order will not alter and a move up system will apply. **The onus is on the competitor to confirm/check their start times the evening before the competition.** All changes will be posted on the notice board in the Riders XOXO Bubbles & Beans Marquee and will be updated on the Brisbane CDI website. We will endeavour to keep changes to a minimum.

DECLARATION OF STARTERS (CDI3* GP & CDI-Y)

Refer FEI Dressage Rules, Art 424

CDI3* GP & CDI-Y: Declaration of starters: must be done by midday for the following day's competitions. Riders who have not declared by midday will be considered as a starter for the competitions entered at the closing date of entries. Declarations can be made at the Riders XOXO Bubbles & Beans Marquee.

WITHDRAWALS/SCRATCHINGS:

- National Competitions Refunds will be processed as per the 2016 Saddleworld Brisbane CDI Schedule.
- CDI Competitions refer to article 424 of the current FEI Dressage rules.
- Competitors wishing to withdraw at the event **MUST** complete a **Withdrawal Form** that is available at the Event Office. This is for **ALL** classes.

FREESTYLES & GRAND PRIX SPECIAL

Grand Prix CDI Freestyle – all horses in the Grand Prix CDI who gain a score of 60% or more will be eligible for the Grand Prix CDI Freestyle.

CDI-Y Freestyle – all horses from the CDI Young Rider Individual competition who gain a minimum score of 60% are eligible for the CDI-Y Freestyle.

Grand Prix CDN Freestyle – the top 4 horses from the CDN Grand Prix who gain a score of 58% or more will be eligible for the Grand Prix CDN Freestyle.

EA Medium Tour Freestyle – all combinations in the Intermediate B who gain a score of 58% or more will be eligible for the EA Medium Tour Freestyle.

Intermediate Freestyle – all combinations in the Intermediate 1 or Prix St Georges who gain a score of 58% or more are eligible if nominated.

Advanced Freestyle – all combinations that have entered the Advanced Freestyle have been accepted to compete.

Grand Prix Special CDI – all horses in the Grand Prix CDI who gain a score of 60% or more are eligible if nominated.

Grand Prix Special CDN – all horses in the Grand Prix CDN who gain a score of 58% or more are eligible if nominated.

It is compulsory for CDI riders to ride the freestyle if they qualify in their respective competitions.

Please hand in your music to staff in the Riders XOXO Bubbles & Beans Marquee by **9 AM, Thursday July 14**. Please ensure that it is clearly labelled with the rider's name, horse's name and the freestyle competition you are competing in. Please have a back-up copy available.

Freestyle Practice times will be posted on the notice board in the Riders XOXO Bubbles & Beans Marquee.

QLD YOUNG HORSE & PONY CHAMPIONSHIPS

Round 1 – will be ridden in groups of two, as per the draw, and the test will be commanded.

Round 2 – Conditions of Eligibility:

The top 10 placed horses or ponies (including equals) from round one will go forward to the second round provided they have attained a score of no less than 6.5 (65%) in the first round. The winner of the 2nd round will be named the "Age Group" 2016 Qld Young Dressage Horse or Pony Champion.

VETERINARY MATTERS

It is compulsory for all Competitors to fill out and sign a QSEC Horse Health Declaration on arrival at the event. The form can be downloaded here:

If you are competing at the indoor, you must hand your completed form to the Stable Manager before competing or riding at the venue. If you are competing at the Outdoor Arenas (Barr Oval), and are parking at the Outdoor Arena Complex, you must hand your completed form to Gear Check before you ride.

Horses entered in the **CDI-3* Grand Prix** and the **CDI-Y** are required to take part in the Horse Health Arrival Inspection and the Fitness Inspection (Trot-up):

- **Horse Arrival Examination** (Thursday 14 July, between 2.00pm and 3.30pm) in the stable complex. Riders are to present their horses to the Vet and Steward between these times. Riders must have their **EA Horse Identification Document (CDI-Y)** or **FEI Passport** or EA

ID Document and FEI Recognition Card (**CDI-3* GP** horses) with them to hand to officials at this time.

- **Fitness Inspection (Trot-up)** – Thursday, 14 July, 4.40pm to 5.20pm. The time draw will be posted on the Brisbane CDI website and updated versions at the event in the Riders XOXO Bubbles & Beans Marquee (please check for updates).

Riders at all levels must have their horse's **EA papers** available for inspection if requested. **Swabbing** may take place. **Penalty fines** will be imposed for those who do not have their horse papers available at the event.

Competitors are to pay for any veterinary treatment and supplies provided by Treating Vets during the event.

If you need to call a vet to attend to your horse while at the event, the Organising Committee **MUST** be notified.

ARENA FAMILIARISATION

Tuesday 12 July:

The warmup arena at the indoor arena is available for use. The indoor arena is closed to horses to enable setup.

Wednesday 13 July:

The indoor arena and the warmup arena at the indoor are available for use from 9.00AM to 6.00PM. There may be some disruptions due to setup at times.

Outdoor Arena Complex (Barr Oval) – grass area open all day and ride around competition arenas only.

Thursday 14 July:

Indoor Arena open: 6.45AM to 8.45AM and 5.00PM to 6.00PM

Friday 15 July:

Indoor Arena open: 6.00PM to 6.40PM

Riders are permitted to ride in the competition and training arenas at these set times. An arena familiarisation timetable will be posted on the CDI website, but competitors are advised to check the notice board in the Riders XOXO Bubbles & Beans Marquee for updated times.

A timetable will be posted on the notice board in the Riders XOXO Bubbles & Beans Marquee for Individual Freestyle Music test times.

WHIPS & GEAR

A reminder that whips that do not comply with current EA rules (must not exceed 1.2m in entirety for horses, and 1.0m for ponies), will not be allowed in the **warm-up** and **competition** areas. A whip may be carried in all National Competitions.

Whips CDI Competitions: At all international events, it is forbidden to carry a whip of any kind while competing in the arena. However, the use of one whip (maximum 120cm), in the practice area is allowed. **The whip must be dropped before entering the space around the competition arena or the athlete will entail a penalty** (refer Art. 430). Upon arrival on the showground, only the rider when riding, walking, leading or lunging a horse (lunge whip allowed), is allowed to carry a whip (max. 1.2m) anywhere on the showground. The groom may also walk, lead and lunge a horse as above. Other parties are allowed to carry a whip provided it is not in connection with the training of the horse.

Whips Young Horse & Pony Competitions: a whip may only be carried in the 4YO Young Horse and Young Pony competitions. Whips are not permitted in the 5YO and 6YO competitions.

Head Wear: an approved helmet is to be worn in training and practice areas. Competition attire including headwear is allowed in the final warm-up arena. At all other times, an approved helmet must be worn.

Riders in the CDI-Y competitions: an approved helmet must be worn at all times when riding, and also during the Fitness Inspection (trot-up).

Riders under 18 years of age: an approved safety helmet must be worn at all times.

Young Horse Competitions: an approved safety helmet must be worn at all times.

Bridle Numbers: Riders are responsible for providing bridle numbers for their horses. **Allocated Bridle Numbers as per the draw** must be worn whenever a horse is out of the stable, for example when grazing or training. We suggest owners have two sets of numbers on hand, one for the head collar and the other for competition. Competitors grazing horses must take extreme care and have horses under full control at all times. If grazing horses appear to be upsetting competing horses or horses under saddle, they will be asked to return to the stables. **Please do not graze or lead horses close to the competition arenas when horses are competing.**

STABLES & CAMPING

Stabling & Camping Allocation: The stabling and camping allocation is being sent with this Competitor Information Pack and will also be posted on the CDI website. Some competitors still owe fees for stabling and camping and have been contacted about this. You need to pay these fees prior to the event or your stable will not be unlocked when you arrive. All requests have been considered and every effort made to satisfy them, but this has not been possible in all cases. Preference has been given to competitors travelling the longest distances and those staying for longer periods.

Stable Security: Only authorised people will be admitted into the stables from 6.00pm to 6.30am. Riders, nominated groom and one official owner will be given a "wrist band" on arrival collectable when registering at the Riders XOXO Bubbles & Beans Marquee from Wednesday afternoon. Entry to stables after hours will only be permitted to riders/grooms/owners who have the appropriate wrist band.

Horse Arrival times are restricted to day light hours only between 6.30am and 6.00pm daily.

Cheryl Stephen is the Stable Manager during the event. Cheryl will be staying on site from Wednesday, July 15. Please contact Cheryl if you are having transport problems and delayed arrival is expected (see Handy Telephone Numbers page for phone details).

Arrival Procedure: Upon arrival at the stable complex you will be greeted by the Stable Manager. Cheryl will take your completed Horse Health Declaration Form from you, note your arrival date, and show you to your camping site and stables.

Departure Procedure: When you are ready to depart the stable complex you must notify the Stable Manager. Cheryl will inspect your stable for cleanliness, lock your stable and note your departure date.

Note: Please bring your own feed and water bins as these are not provided by QSEC. It is also advisable to bring your own stable cleaning tools and wheelbarrow as these are in limited supply at the venue.

Stable Bedding: Your stable will be pre-filled with 4 wheelbarrow loads of shavings if you are staying up to and including 4 days, and 8 wheelbarrow loads of shavings if you are staying 5 days or longer. Extra bedding in the form of Hisorb shavings can be ordered from Feedmania (see Handy Telephone Numbers page). Orders placed by 11am each day will be delivered that afternoon.

Stable Cleaning: with your entry you have paid a \$50 stable bond. This will be refunded post event if your stable is left clean – clean means that all bedding, feed & urine has been removed from the stable and it has been SWEPT clean (not merely scraped out with a shovel). Any damage to stables as noted by QSEC is payable by competitors and the minimum fee for damage is \$200. This fee will be charged back to competitors.

Competitor Day Parking: Day parking is not available for horses competing at the indoor complex. Competitors competing at the Outdoor Arena Complex (Barr Oval) are permitted to day park at Barr Oval.

Car Parking: Car parking is available on site. Please follow instructions from the Centre Management staff regarding where to park your vehicles. Vehicles are not allowed in the competition and training areas. **Only accredited persons are permitted to park in the stable complex.**

Accreditation/Tickets: There is no General Admission Fee to the venue, however all Riders/Grooms (1 per horse) and one owner per horse will receive a “wrist band” on arrival at the venue. This will allow admittance to the stables at all times. Riders, grooms and one owner per horse must report in person to collect their wrist band at the Riders XOXO Bubbles & Beans Marquee.

From Wednesday afternoon, the Riders XOXO Bubbles & Beans Marquee (see map attached) will be open to **issue accreditation and Brisbane CDI show bags.** Each rider will receive a Brisbane CDI show bag with a complimentary copy of the programme booklet along with other souvenir items.

CATERING

Catering will be available during the day from Wednesday to Sunday and Saturday night.

TEST PAPERS

On completion of the competitions, competitors will be able to collect their test sheets from the Riders XOXO Bubbles & Beans Marquee.

PRESENTATIONS

A presentation schedule will be posted on the notice board in the Riders XOXO Bubbles & Beans Marquee. Riders are requested to be neatly attired in competition attire for presentations. Presentations in the main will be unmounted and will take place in the Riders XOXO Bubbles & Beans Marquee (please check the notice board). All freestyle presentations will be mounted, as will the Sharon Doe. We invite non-riding owners to be present at the prize giving ceremonies.

Participation in presentations is compulsory as per the Brisbane CDI Schedule.

Prize money will be deposited into your nominated bank account within 14 working days of the event.

STATE OF ORIGIN TEAMS

Teams will be posted on the notice board in the Riders XOXO Bubbles & Beans Marquee, and presentations of these awards will be noted on the Presentation Timetable. All members of teams are requested to be present at the presentations.

BRISBANE CDI SOCIAL FUNCTIONS

Welcome Function Thursday 14th July from 6.00pm to 9.00pm in the Riders XOXO Bubbles & Beans Marquee. This is a **Complimentary** welcome function for riders, owners, grooms, sponsors & officials.

Riders XOXO Bubbles & Beans Marquee is the social hub of the event, offering a coffee bar and champagne/fine wine bar. This is also where our unmounted presentations will take place, and where all rider/event related information will be posted on the notice boards. It is an area to relax in and catch up with friends, conveniently located in the middle of our extensive trade village and is also the home of our Silent Auction.

WELFARE OF THE HORSE – FEI CODE OF CONDUCT

The Fédération Equestre Internationale (FEI) expects all those involved in international equestrian sport to adhere to the FEI's Code of Conduct and to acknowledge and accept that at all times the welfare of the horse must be paramount and must never be subordinated to competitive or commercial influences.

1. At all stages during the preparation and training of competition horses, welfare must take precedence over all other demands. This includes good horse management, training methods, farriery and tack, and transportation.
2. Horses and competitors must be fit, competent and in good health before they are allowed to compete. This encompasses medication use, surgical procedures that threaten welfare or safety, pregnancy in mares and the misuse of aids.
3. Events must not prejudice horse welfare. This involves paying careful attention to the competition areas, ground surfaces, weather conditions, stabling, site safety and fitness of the horse for onward travel after the event.
4. Every effort must be made to ensure that horses receive proper attention after they have competed and that they are treated humanely when their competition careers are over. This covers proper veterinary care, competition injuries, euthanasia and retirement.
5. **The FEI urges all involved with the sport to attain the highest levels of education in their areas of expertise.**
