EA & IQ RULES AND CONDITIONS OF ENTRY

- 1. Junior members are classed as members under 18 years of age.
- It is the responsibility of all riders/owners/lessee/competitors to be familiar with and aware of all Equestrian Australia rules which govern this sport. For example; the constitution, by-law and policies consist of, but are not limited to: Codes of Conduct, Equine Anti-Doping and Medication Control Regulations. - 3. Equestrian Australia (Queensland Branch) Membership cards <u>MUST</u> be presented to collect wristbands and ride otherwise you will need to pay the Restricted Membership fee.
- 4. All RIDERS must wear protective headgear to the current Australian Standard. The retaining chin straps must be fastened at all times.
- 5. For safety reasons, ALL RIDERS must wear suitable riding boots that are heeled and soled, with little or no tread, at all times when riding at EA events.
- 6. Dress code: light coloured jodphurs e.g. white, beige, cream, light colour collared shirt (long or short sleeves) with tie or stock, jackets are optional.
- Horses to wear white saddle cloth or school saddle cloth. For all saddlery rules refer to the following discipline codes:
