## EA & IQ RULES AND CONDITIONS OF ENTRY

1. Junior members are classed as members under 18 years of age.
2. It is the responsibility of all riders/owners/lessee/competitors to be familiar with and aware of all Equestrian Australia rules which govern this sport. For example; the constitution, by-law and policies consist of, but are not limited to: Codes of Conduct, Equine Anti-Doping and Medication Control Regulations. Please refer to the Member Protection Policy, link listed below.

3. Equestrian Australia (Queensland Branch) Membership cards **MUST** be presented to collect wristbands and ride otherwise you will need to pay the Restricted Membership fee.
4. All RIDERS must wear protective headgear to the current Australian Standard. The retaining chin straps must be fastened at all times.
5. For safety reasons, ALL RIDERS must wear suitable riding boots that are heeled and soled, with little or no tread, at all times when riding at EA events.
6. Dress code: light coloured jodphurs e.g. white, beige, cream, light colour collared shirt (long or short sleeves) with tie or stock, jackets are optional.
7. Horses to wear white saddle cloth or school saddle cloth. For all saddlery rules refer to the following discipline codes:

9. All protests must be submitted in writing to the ringmaster no later than sixty (60) minutes following the completion of the event in question. All protests shall be accompanied by a cash fee of \$150.00 which shall be forfeited should the protest be deemed frivolous.
10. **Payments** - Payments are NON-REFUNDABLE and NON-TRANSFERABLE.
11. **Prize/s** - Any prize/s not collected on the day of the show will be forfeited.

2. All vehicles and equipment accompanying the horses will be cleaned to remove all solid material that could contain disease agents, and then disinfected.

#### I FURTHER DECLARE THAT:

3. The information contained in this Biosecurity Declaration is true and correct to the best of my knowledge.
4. I agree to abide by all conditions that may be imposed at any time by the Event Organising Committee/Manager.
5. I acknowledge that in failure to comply, I may be directed to leave and my nominations will be forfeited.
6. I acknowledge that decontamination and disinfection procedures may be required of me if instructed by the Event Organising Committee/Manager.
7. I acknowledge that there is a possibility that horses might become infected with disease agents as a result of any movements and if necessary horses and premises will be quarantined in accordance with any Legislation covering such occurrences including policies and procedures in effect at that time. I agree and acknowledge that the Manager/Event Organising Committee, it's State or National Affiliated bodies and their members are not in any way liable for any cost, expense, loss, damage, claim, action, proceeding or other liability incurred by or made against me as a result of any movement of horses to the Event/Farm.
