GENERAL INFORMATION

The Brisbane CDN Organising Committee would like to thank you for your entry and wish you the very best of luck at the event. Please read through the following important information regarding the Brisbane CDN. Regular updates will be posted on the CDI web page and on our Facebook page (search Brisbane CDI).

COVID-19

In order for this event to go ahead, the event has a strict COVID Safety Plan we must adhere to. The most important aspect is data capture for contact tracing. It is essential that all attendees scan in and check out of the venue every time they enter and exit. This includes all grooms, family members and other persons coming into the venue. For this event we highly recommend you download the Nominate Equestrian app which is a very quick and simple way to record your presence at the venue.

In addition, we need to adhere to strict social distancing. Please respect this requirement and do not socialise in trucks. We also need to restrict persons at the stables. I fully understand the disappointment this may cause, but we please request persons at the stables are limited to only persons essential for getting you in the ring. That is, one groom and one essential family member. If you have to bring your children, children under 12 must be supervised by a responsible adult at all times, and we understand there may be a need to bring an extra person for this role.

Please familiarise yourself with the event COVID Safe Plan and please adhere to recommendations in this work plan throughout the event

QSEC IS A GLASS FREE VENUE

As users of this great venue we need to observe and comply with the laws that the venue is run under, which are the same laws as other large sporting venues in Qld, such as Suncorp Stadium and the Gabba. If you bring glass onto the venue in your vehicles, then that's where it needs to remain – **DO NOT** place empty bottles in the QSEC rubbish bins – take them home with you. There are large fines for people who do not abide by these rules, and as these rules have been flaunted by users of the venue, spot checks have started to be carried out.

FACILITIES

We request that competitors take the utmost care in looking after the wonderful facilities that are being provided at QSEC. Please take pride in this fantastic venue and keep the toilets and amenities block clean. Recycling bins are located throughout the venue and we request that you place your rubbish in the appropriate bin. The indoor arena precinct is a non-BYO alcohol area – that is, you can only consume alcohol that has been purchased at the bar at the indoor arena.

DOGS

Dogs **ARE NOT PERMITTED** at QSEC. Anyone found with a dog, or any animal other than a horse, will be required to take the animal home immediately.

BIOSECURITY

Queensland biosecurity legislation requires that we must all keep Movement Records when we take our horses somewhere. A Movement Record can take many forms – it can be a written note in a diary, a horse health declaration form, a note in your smart phone, etc. It needs to record the date of the horse movement, a description of the horse, the property of origin (including PIC), where you are going (including PIC), and who completed the record. You are required to keep these records for 2 years.

The Horse Health Declaration form that you will be required to submit on arrival at the Brisbane CDN can be your Movement Record, however, as we require you to submit your horse health dec to us, you will need to take a copy of the form, i.e. photo with your phone. You will also need to create a Movement Record for your trip home. QSEC's PIC is QGCB1219.

SPRAYING FOR COMPETITORS FROM NSW, VIC OR TICK-FREE AREAS

We have arranged for an accredited stock inspector, to come to the venue on Saturday September 19th to spray horses returning to Tick Free areas. The stock inspector will help you with the paperwork. Provided you cross the border within 24 hours of being sprayed, you will not have to stop at a Treatment Facility, such as Kirra, on your way home. We hope that this will make your journey home to NSW much more stress free. The cost of spraying is being subsidised by the event, but you will be asked to pay **\$40 per horse** directly to the stock inspector (the event will pay \$30). Please have this money in cash at the time of spraying and give it to the stock inspector. **ALL RIDERS WHO WISH TO HAVE THEIR HORSES SPRAYED AT THE VENUE NEED TO CONTACT ANITA BARTON BY SEPTEMBER 7TH.**

Draws will be continually updated as scratchings are received.

A **final revised** draw may be necessary the day before each competition to allow for withdrawals. The starting order will not alter and a move up system will apply. **The onus is on the competitor to confirm/check their start times the evening before the competition.** All changes will be posted on the notice board in the Saddlefitter Marquee and will be updated on the Brisbane CDN website. We will endeavour to keep changes to a minimum.

- Competitors wishing to withdraw at the event **MUST** complete a **Withdrawal Form** that is available at the Event Office. This is for **ALL** classes.

FREESTYLES & GRAND PRIX SPECIAL

Grand Prix CDN Special & Freestyle – all combinations that have entered the Grand Prix CDN Freestyle have been accepted to compete.

CDN-P Freestyle – all combinations that have entered the FEI-Pony Freestyle have been accepted to compete.

CDN-J Freestyle – all combinations that have entered the FEI-Junior Freestyle have been accepted to compete.

CDN-Y Freestyle – all combinations that have entered the FEI-Young Rider Freestyle have been accepted to compete.

FEI Intermediate A/B Level Freestyle – all combinations that have entered the Intermediate A/B Freestyle have been accepted to compete.

Intermediate Freestyle – all combinations that have entered the Intermediate I Freestyle have been accepted to compete. The top 15 combinations in the Intermediate I will be offered a ride.

Advanced Freestyle – all combinations that have entered the Advanced Freestyle have been accepted to compete.

In order to restrict sharing of items we request that freestyles be handed in to the Sound Manager via Dropbox. All competitors entered in the freestyle will be emailed instructions and a link to upload their music to Dropbox. Please ensure your music is uploaded by **3 PM Wednesday, September 16th**. Please have a back-up copy available on USB.

Time will be set aside for your music to be checked by our audio technician to ensure it is compatible with the audio system. Riders will need to specifically request to ride if they wish to practice their freestyle on their horse, except for the Grand Prix competitors. The music practice timetable will be posted on the notice board in the Saddlefitter Marquee.

To request a time to practice your freestyle on your horse you must contact the event director, Anita Barton by 12 noon, Wednesday, September 16th.

VETERINARY MATTERS

It is compulsory for all Competitors to fill out and sign a QSEC Horse Health Declaration on arrival at the event. The form can be downloaded here:

If you are stabling at the venue, you must hand your completed form to the Stable Manager upon arrival at the venue. If you are competing at the Outdoor Arenas (Barr Oval), or are parking at the Outdoor Arena Complex, you must hand your completed form to Gear Check before you ride.

Riders at all levels must have their horse's **EA papers** available for inspection if requested. **Swabbing** will take place. **Penalty fines** will be imposed for those who do not have their horse papers available at the event.

Competitors are to pay for any veterinary treatment and supplies provided by Treating Vets during the event.

If you need to call a vet to attend to your horse while at the event, the Organising Committee **MUST** be notified.

STALLIONS

All stallion riders, grooms and owners must be aware of and abide by, the EA Stallion Safe Practice Policy Rules and Regulations, effective 1 July, 2018.

ARENA FAMILIARISATION

An arena familiarisation timetable will be posted on the CDI website and riders are permitted to ride in the specified arenas at these set times. Competitors are advised to check the notice board in the Saddliffiter Marquee for updated times at the event.

INDOOR ARENA 2

Due to space constraints, if you are competing in Indoor Arena 2, you will need to enter the arena and start your test from inside the arena once the judge has rung the bell. Due to COVID Management and the need to reduce many people handling the same item this arena will NOT have a gate opener to let you in and out.

GEAR CHECK

Under the current EA Dressage rules, it is compulsory for every horse and rider combination to have a gear check for every test they ride. The stewards will advise whether gear checks will take place before or after your test.

WHIPS & GEAR

A reminder that whips that do not comply with current EA rules (must not exceed 1.2m in entirety for horses, and 1.0m for ponies), will not be allowed in the **warm-up** and **competition** areas. A whip may be carried in all EA National Competitions.

Whips FEI Competitions: As this event is a State Championship, it is forbidden to carry a whip of any kind while competing in the arena. However, the use of one whip (maximum 1.2m), in the practice area is allowed. **The whip must be dropped before entering the space around the competition arena or the athlete will entail a penalty** (rule 5.6e). Upon arrival on the showground, only the rider when riding, walking, leading or lunging a horse (lunge whip allowed), is allowed to carry a whip (max. 1.2m) anywhere on the showground. The groom may also walk, lead and lunge a horse as above. Other parties are allowed to carry a whip provided it is not in connection with the training of the horse.

As the CDN-P and CDN-J are run under EA rules and are equivalent to EA Elementary and Medium levels respectively, a whip may be carried in these classes.

Head Wear: an approved helmet is to be worn in training and practice areas. Competition attire including headwear is allowed in the final warm-up arena. At all other times, an approved helmet must be worn.

Riders in the CDN-P, CDN-J, CDN-Y & CDN-U25 competitions: an approved helmet must be worn at all times when riding if you are under 26 years of age.

Riders under 25 years of age: an approved safety helmet must be worn at all times.

Bridle Numbers: Riders are responsible for providing bridle numbers for their horses. **Allocated Bridle Numbers as per the draw** must be worn whenever a horse is out of the stable, for example when grazing or training. We suggest owners have two sets of numbers on hand, one for the head collar and the other for competition. Competitors grazing horses must take extreme care and have horses under full control at all times. If grazing horses appear to be upsetting competing horses or horses under saddle, they will be asked to return to the stables. **Please do not graze or lead horses close to the competition arenas when horses are competing.**

STABLES & CAMPING

The Stable Complex is accessible through Gate 14, via Old Gympie Road.

Stabling & Camping Allocation: The stabling and camping allocation will be posted on the CDN website. Stabling and camping is controlled through the venue.

Stable Security: A security guard will be posted at the entry to the stables and only authorised people will be admitted into the stable complex. Riders, their pre-nominated groom and pre-nominated essential other persons (maximum 2 per horse) will be given a "wrist band". Wrist bands can be collected when you check in with the stable manager and prove you and all attendees have scanned into the event using the Nominate app. No additional wrist bands will be handed out. Entry to the stables will only be permitted to riders/grooms/essential persons who have the appropriate wrist band. All gates into the stabling complex will be locked from 3pm each day until 6.30am – instructions on how to access the stable complex will be provided with the stable allocation or from the Stable Manager.

Horse Arrival times are restricted to day light hours only between 6.30am and 6.00pm daily.

Cheryl Stephen is the Stable Manager during the event. Cheryl will be onsite from Tuesday September 14 from 9AM through to Sunday September 20. Please contact Cheryl if you are having transport problems and delayed arrival is expected (see Handy Telephone Numbers page for phone details).

Arrival Procedure: Upon arrival at the stable complex you must scan the QR Code using your Nominate app at the gate and record details of all persons in your vehicle. Upon entry into the complex you will be greeted by the Stable Manager. Cheryl will take your completed Horse Health Declaration Form from you, note your arrival date, and show you to your camping site and stables.

Departure Procedure: When you are ready to depart the stable complex you must notify the Stable Manager. Cheryl will inspect your stable for cleanliness, lock your stable and note your departure date. You must check out of the Nominate app. It is your responsibility to check out. If there is a COVID incident occurring at the event after your departure and you have not checked out of the app you will still be required to isolate as if you had been present at the time of the incident.

Note: Please bring your own feed and water bins as these are not provided by QSEC. It is also advisable to bring your own stable cleaning tools and wheelbarrow as these are in limited supply at the venue.

Stable Bedding: Your stable will be pre-filled with shavings. Extra bedding in the form of Hisorb shavings can be ordered from Petstock Caboolture (see Handy Telephone Numbers page). Orders placed by 11am each day will be delivered that afternoon.

Stable Cleaning: with your entry you have paid a stable bond. This will be refunded post event if your stable is left clean – clean means that all bedding, feed & urine has been removed from the stable and it has been SWEPT clean (not merely scraped out with a shovel). Any damage to stables as noted by QSEC is payable by competitors and the minimum fee for damage is \$250. This fee will be charged to competitors.

Stable Cleaning Service: A stable cleaning service is offered by Liam Stephen for \$25 per stable. Please book and pay for this service with the Stable Manager, Cheryl Stephen.

Competitor Day Parking: Day parking is not available at the stable complex. Day parking is available at the Outdoor Arena Complex, accessible through Gate 15 via Old Gympie Road. This applies to all competitors regardless of which arenas your competitions are held in.

Car Parking: Car parking is available on site. Please follow instructions from the Centre Management staff regarding where to park your vehicles. Vehicles are not allowed in the competition and training areas. **Only accredited persons are permitted to park in the stable complex.**

DAY YARD BOOKINGS

Day yards are available at the Outdoor Arena Complex. These are free but need to be booked to ensure that they are unlocked. Please let the event director know if you require a day yard.

CATERING

Catering will be available during the day from Wednesday to Saturday.

TEST PAPERS

This event uses the Nominate paperless scoring. Test sheets will be emailed to riders after signed off by the judge. Check you junk email if you do not receive your email. If its still not received email Nominate nominate@nominate.com.au

PRESENTATIONS

Social distancing will be essential at presentations. A maximum of 48 persons are permitted in the Saddlefitter Marquee at any one time. We request that only riders participating in the presentation enter the Saddlefitter Marquee during presentations. All other persons should remain outside the Saddlefitter Marquee. We will roll up the sides to ensure good visibility. Riders should remain 1.5m apart when on the podium and we request no physical touching during the presentation.

A presentation schedule will be posted on the notice board in the Saddlefitter Marquee. Riders are required to be neatly attired in competition attire for presentations. Presentations in the main will be unmounted and will take place in the Saddlefitter Marquee (please check the notice board). All freestyle presentations will be mounted. We invite non-riding owners to be present at the prize giving ceremonies.

Participation in presentations is compulsory as per the Brisbane CDN Schedule. If you cannot attend presentation then you need to arrange for someone to collect your prize for you and notify the event director, Anita Barton, before the presentation.

Prize money will be deposited into your nominated bank account within 14 working days of the event.

WELFARE OF THE HORSE – FEI CODE OF CONDUCT

The Fédération Equestre Internationale (FEI) expects all those involved in international equestrian sport to adhere to the FEI's Code of Conduct and to acknowledge and accept that at all times the welfare of the horse must be paramount and must never be subordinated to competitive or commercial influences.

1. At all stages during the preparation and training of competition horses, welfare must take precedence over all other demands. This includes good horse management, training methods, farriery and tack, and transportation.
2. Horses and competitors must be fit, competent and in good health before they are allowed to compete. This encompasses medication use, surgical procedures that threaten welfare or safety, pregnancy in mares and the misuse of aids.
3. Events must not prejudice horse welfare. This involves paying careful attention to the competition areas, ground surfaces, weather conditions, stabling, site safety and fitness of the horse for onward travel after the event.
4. Every effort must be made to ensure that horses receive proper attention after they have competed and that they are treated humanely when their competition careers are over. This covers proper veterinary care, competition injuries, euthanasia and retirement.
5. **The FEI urges all involved with the sport to attain the highest levels of education in their areas of expertise.**

CODE OF CONDUCT

Code of conduct: The organising committee of the Brisbane CDI and Queensland Dressage Championships values the attendance of all riders, officials, spectators, sponsors, volunteers and supporters HOWEVER it is a condition of attendance at this event that each person present on the grounds is bound by the rules, policies and by-laws of Equestrian Australia. This includes comments made on social media. Any complaints or conflicts should be managed with respect through official channels. As per EA Disciplinary By-Laws 3(j) any other person or organisation (for example, a parent/guardian, spectator or sponsor) who or which agrees, in writing or otherwise (whether on a ticket, entry form, conditions of entry displayed at a venue etc) to be bound by these By-Laws. Any rider, parent, official or associate to be found in breach of these By-Laws will be requested to leave the venue immediately and all entry fees and prizes deemed forfeit.
