- The information supplied in this form is true and correct, to the best of my knowledge.
- I agree to abide by all conditions and directions given by QSEC staff, Event Organiser or any other authorising body.
- I acknowledge that failure to comply with the above may result in refusal of entry to the venue; disqualification or other disciplinary action as decided by QSEC or the Event Organisers.
- I acknowledge that there is a possibility that horses/animals might become infected with disease agents as a result of any movements and if necessary horses/animals may be quarantined in accordance with any legislation covering such occurrences including policies and procedures in effect at that time.
- In the event of horse movement restrictions, each owner/person in charge will be responsible for the care, maintenance and cost of their horses/animals, including feeding and watering.
