#### **CHAIRPERSONS' REPORT**

It is a pleasure to present you with the 2014 Annual Report.

As Chair of Equestrian Queensland, I am pleased to report the organisation is in a sound financial position, with steady growth and a healthy surplus. This is particularly pleasing given a challenging year involving the departure of our long serving General Manager and the adoption of a contentious national Hendra Vaccination Bylaw which has caused much frustration and division within the membership and broader equine community.

However, by continuing to engage and listen to our members, support the volunteers and sport committees and improving communication both internally and externally to stakeholders, we remain optimistic that our collective strength will empower us to convert challenges into opportunities and maintain our prominence and profile within the community

The Board has continued its focus on driving the organisation's strategic direction based on four pillars of:

- Financial performance to make the sport financially viable.
- Membership services that provide value to our members.
- Participation across all levels of the sport.
- Excellence in the delivery of equestrian sport.

#### **Financial performance**

Equestrian Queensland is fortunate to be receiving the maximum funding for a tier two sport (\$200,000 a year) and entering into the second of a three year indicative commitment from the Queensland Government (2014-2016). The continuation of this level of government funding will confidence in future planning as we strive to maintain the financial sustainability of our sport.

#### Member services

The health and safety of our members and horses remains a priority.

We have continued to work with Government departments including Workplace Health and Safety in Queensland Health, Biosecurity Queensland through the Department of Forestry and Fisheries (DAFF) in addition to the industry through the Queensland Horse Industry Alliance (QHIA) to ensure our affiliates, sport committees and event organisers are aware of their responsibilities and equipped to deal appropriately with a biosecurity incident should one occur.

While it is an evolution of continuous improvement, it is encouraging to see the increased utilisation of the biosecurity template by event organisers since its introduction in early 2014, which positions them as the pioneers on the national stage.

Equestrian Queensland has always encouraged members to make an informed choice regarding vaccination as an effective risk mitigation tool for Hendra Virus and it is pleasing to see the voluntary uptake strong in Queensland with more than 50,000 horses vaccinated representing more than all the other states combined.

#### **Participation**

The 'one sport' national membership structure completed its first full year in 2014 with 6% membership growth, however, requires ongoing review to improve the value proposition and broaden the relevance to a larger participation base.

Equestrian Queensland and especially the dressage and interschool sport committees continue to provide an inclusive and welcoming environment supporting para equestrian

development to provide opportunities for participation and excellence for riders with disabilities.

Equestrian Australia have recently renewed their Memorandum of Understanding with Pony Club Australia and partner in The Ready Set Trot program which is the entry level national participation program which feeds into Queensland's well established and highly successful interschool system.

#### Excellence

A number of Queensland riders worked hard to secure selection for the 2014 World Equestrian Games in Normandy, France. A summary of these results are covered in the CEO and respective sport committee reports as are the recipients of the annual awards which recognise excellence celebrate contributions across a number of key categories.

#### Thank you

I would like to personally thank all members of the EQ Board in 2014 for their strong engagement and robust discussion on the many issues before them over the past year and for the manner in considered matters from a whole of sport perspective.

We are fortunate to have the diversity of skill and passion our directors bring to the governance of our sport and like our sport committees, contribute their expertise on a voluntary basis.

On behalf of the Board, I wish to thank the staff of Equestrian Queensland for their efforts and for the professional manner in which they service the sport. In particular, Samantha Duffy for her outstanding effort in caretaking the CEO role from March-July and our new CEO Matt Helmers who assumed the role in August.

I also wish to acknowledge the enormous contribution and commitment of the many passionate and hardworking volunteers who are the backbone of the sport.

On behalf of Equestrian Queensland and all of our sport committees, I also wish to express our sincere appreciation to the organisations that have supported the sport over the course of the past year through product or cash sponsorship.

I wish all our members, whether you're a rider, official, owner, coach, administrator or volunteer, all the best for a wonderful 2015.

I also thank the members for entrusting me with the responsibility of governing your sport over the past six years and for my colleagues for electing me as chair.

#### **CEO'S REPORT**

I'd firstly like to thank the board for my appointment in August and entrusting me with the privilege of managing this prestigious sport in our great state.

Despite familiarity with leadership roles facilitating collaboration across a range of sports, I am new to equestrian and express my gratitude to members for a warm welcome.

I give my commitment to understand, advocate and promote equestrian sport and develop meaningful relationships of authenticity and integrity with internal and external stakeholders, so we can all continue to develop and grow together.

The Hendra Bylaw adopted by Equestrian Australia in July 2014 created much division and frustration within the equine community, presenting a very challenging environment to commence a new tenure.

Member perseverance on the contentious issue of mandating vaccination has resulted in some recent changes which are more widely embraced amongst the membership. We are optimistic that through this experience we can develop a consultative and cohesive approach to work in alignment to provide a safe environment to grow the sport.

Our strategic direction continues to be guided by four key pillars:

- Financial Performance to make the sport financially viable
- Membership Services that provide value to our members.
- Participation across all levels of the sport
- Excellence in the delivery of equestrian sport

As the treasurer's report attests, Equestrian Queensland has expanded revenue on 2013 and delivered its third consecutive consolidated surplus which has strengthened equity to a more stable position after some difficult but necessary workforce contraction was required in 2012.

We have been particularly frugal in 2014, largely due to an incredible feat of the operations manager who was also acting as the CEO for five months. The future focus will be to expand and diversify revenue while maintaining operational efficiency.

Equestrian Queensland has an extensive list of more than three hundred affiliates, which predominantly includes clubs, schools and show societies. The whole is certainly greater than the sum of its parts.

Operations would not exist without the extensive team of highly skilled volunteers who are dedicated to serving their sport. The leadership from your elected representatives in each of the seven sporting committees (Dressage, Jumping, Eventing, Interschool, Vaulting, Carriage Driving & Show horse) is evidenced in their reports, which summarise the comprehensive calendar of events providing a diverse range of participation opportunities under one unified membership.

We are also incredibly fortunate to have a small but highly engaged office team who are committed to supporting our diverse family.

In particular, I would like to acknowledge our Operations manager, Samantha Duffy, whose experience and unwavering commitment has been a rock of stability through some challenging transitional times. Also to Sasha Ulasowski (Medication, sports development funding, coach & officials education,) and Jodie

Daly (administration including results and entry checks) who have been loyal contributors and Christine Thompson (Interschool and Clubs SDO) replaced Katherine Plomer in August and has hit the ground running.

Despite the 'one sport' national membership structure achieving 6% growth in its first full year in 2014, we understand the importance of improving the value proposition to members while continuing to broaden relevance to a larger participation base.

In addition to more than \$100,000 annual allocation to sport committees and affiliated clubs to support development programs and events, 2014 included a further \$10,000 specifically for the development of Officials and Coaches.

More than thirty rider development clinics were delivered to more than six hundred participant's state wide, including remote locations such as Longreach.

Various workshops were delivered across a range of key areas including planning, financial procedures, biosecurity and a seminar for website development for the updated platform which was launched in September.

Equestrian Queensland continues to have exceptional hallmark events including:

- 2014 Saddleworld Brisbane CDI- QSEC
- 2014 Gatton World Cup-Gatton
- 2014 Be The Influence Interschool Queensland State Championships-Maryborough
- 2014 Pryde's Easifeed Queensland International 3 Day Event Warwick
- 2014 Horseland Festival of Dressage- QSEC
- 2014 Caboolture World Cup- QSEC

Although the third largest state my membership, Equestrian Queensland has the largest social media following (5500+ face book likes) and website traffic comparable with New South Wales and Victoria.

Finally, I would like to acknowledge our chair, Peter Toft, for his immeasurable contribution to the sport, serving two full three-year terms. There are not too many who emulate the qualities of humility and altruism. He is always available and never shies away from addressing difficult issues with decisiveness and diplomacy. His generous service has left a valuable legacy of stability for the sustainable development of equestrian sports in Queensland.

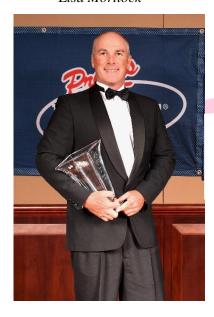

#### **DRIVING REPORT**

A new Queensland carriage driving committee was formed in 2014 with seven dedicated, passionate and visionary members. This committee includes members from across the state including the Lockyer Valley, Darling Downs, Maranoa and Central Queensland regions.

The 2014 year was very successful for carriage driving with significant growth and several outstanding achievements as outlined below:

- Membership growth has seen three clubs become involved with EQLD carriage driving. Warwick & District Carriage Driving Club which is Queensland's most active competition carriage driving club affiliated with EQLD, bringing with it a number of new members and international standard driving facilities. The recent changes to membership structure (one sport, one membership) have also meant that Central Highlands Equestrian Group and Maranoa Equestrian Club have diversified to include carriage driving.
- Carriage driving events have been of a great standard and well attended with Warwick & District Carriage Driving Club running numerous top quality competition events, the most of any carriage driving club in Queensland. Their major events included the Equivet Australia Easter Classic combined driving event and the Riverina Winter Series (four individual events contributing to an overall series winner). Community engagement was also apparent throughout the year evidenced by local sponsor involvement and the overwhelming support of some forty plus volunteers in coordinating carriage driving events.
- Congratulations to all drivers who competed at the first official FEI CAI 1\* events in Australia at AELEC Tamworth in

October. EQLD drivers included pony pair driver Tracie-Lee Borg (Calveston Spirit and Mungala Embarr), and single horse drivers Kurt Dillmann (Starkfeld George), Lindsay Vagg (Major Victree), David Rozynski (Cwmkaren Woody) and Jack Murphy (Colcannon Gough). In the Dressage and Cones CAI 1\*, Tracie-Lee Borg won the pony pair class overall and the top placed Queenslander in the single horse class was Kurt Dillmann, who placed third overall. Queensland drivers dominated the Indoor Combined Marathon CAI 1\* with Tracie-Lee Borg again winning the pony pairs. In the single horse class EQLD drivers took out the top three placings with Kurt Dillmann first, Jack Murphy second and David Rozynski third. World Champion Boyd Exell (AUS) was in attendance and presented the prizes to the winners.

- Dr Wolfgang Asendorf (GER) shared his years of experience in FEI carriage driving course designing with EA members and officials at AELEC Tamworth. It was a wonderful opportunity to learn from the internationally recognised course designer who has decades of experience designing cones courses and marathon courses for club and state level events through to national level and world championship events. EQLD carriage driving committee members Tracie-Lee Borg, Kurt Dillmann, Karyn Dillmann and Eugen Dillmann all successfully completed the FEI course designer course and are now accredited EA officials as well as EQLD driver & official, Robert Edwards. We look forward to seeing Dr. Asendorf's ideas and advice being incorporated in future competitions to challenge Australian drivers.
- Training and development was a priority and to this end drivers were encouraged to attend driving instruction with world driving

champion, Boyd Exell. Many members travelled to NSW and attended the clinic and had lessons with Boyd. Plans are underway for EQLD drivers to access future Boyd Exell clinics and other training workshops in 2015.

Congratulations to everyone involved with Warwick & District Carriage Driving Club on winning the 'Equestrian Queensland Club of the Year 2014' award. This prestigious award was presented to club representative Karyn Dillmann (secretary/treasurer) at the Equestrian Queensland Awards Night in Brisbane on 31January 2015. The club of the year category in 2014 had thirteen nominations from which seven clubs made the finals. To have a carriage driving club win this award is an outstanding achievement for the club and an invaluable endorsement for the sport of carriage driving in Queensland.

The Driving Queensland committee is committed and eager to support carriage driving clubs, competitors and officials in 2015 to further progress all levels of participation in top quality driving events in Queensland.

#### **DRESSAGE REPORT**

During 2014 the Dressage Queensland committee farewelled Chris Lok and Naomi O'Farrell who both tendered their resignations to take up positions on the Equestrian Queensland board. The committee welcomed our new member Leesa Murray as Vice-Chair and also welcomed back Gary Lung.

With the conclusion of the 2014 dressage calendar, the committee would like to thank all of the very hardworking organising committees around Qld who have run approximately 70 official events during the year.

The 2014 calendar year kicked off with yet another successfully run Dressage Education Forum which was conducted at QSEC by the Judges Sub-committee. This group do a wonderful job of encouraging, educating and training Queensland's judges not only for the benefit of dressage but also for the sports of eventing and interschool.

In 2014 the wonderful and hard-working Festival of Dressage team brought to QSEC yet another great day full of educational seminars, entertaining displays and a shopping village full of bargains. This showcase event in Queensland is not only a valuable educational event but also provides very valuable financial support to many facets of dressage throughout the year.

The Saddleworld Brisbane CDI which was held in July was run yet again by Cathie Drury-Klein and a wonderful team of volunteers which meant that this year the event made a small profit.

Also in July was the National Young Rider Championships which was staged in Queensland at QSEC and was run by the Young Rider Sub-committee headed by Kim Tenkate-Cullen. This event was a huge success with riders travelling from interstate and long distances to enjoy this professionally run competition.

The postponement and subsequent cancellation of Queensland State the Championships due to the Equestrian Australia's Hendra By-Law was a huge disappointment to the working committee as well as the Dressage Qld committee. We look forward to the 2015 State Dressage Championships which this year is being trialled in the month of August so that we avoid the risk of heat and rain of mid-October.

2014 saw the very successful Division 2 scheme and Festival of Dressage Leader Board being run at selected events as part of the national Amateur Owner Rider scheme. This scheme was introduced for the sole purpose of encouraging grass root competitors to attend and compete at the larger style events. The Queensland AOR scheme has been proudly supported by the Festival of Dressage Committee and Dressage Queensland and the committees will continue to support scheme in 2015 and look forward to the ever increasing numbers of riders entering these competitions.

Dressage Queensland ended 2014 in a strong financial position which will again allow the committee and sub-committees to grow and develop the sport in Queensland.

The Dressage Queensland committee is looking forward to the 2015 calendar where yet another year of high calibre events will be run by Queensland's valued volunteers.

#### **EVENTING REPORT**

As chair of the Eventing Committee I open this annual report by thanking our hard working and dedicated committee. Through 2014, as a new committee, we have endeavoured to come to grips with the task and to provide good governance for the sport. It has been a steep learning curve and challenge but one that has been embraced by the committee. The committee will miss retiring members Melissa Matthews and Sylvia Roberts. Our thanks are extended to previous committees whose legacy ensured that our sport was in good shape.

During the year the committee has made an effort to involve the stake holders of eventing. We welcomed Matt Gaske as a rider representative to join the committee Matt has been an asset to help narrow the gap between the organising body and riders. The committee welcomed input from Club organisers, a rider's group and squad members who attended separate committee meetings, to have input into the preparation of the 2015 calendar, the format for running of squad clinics during 2015 and to provide feedback on how we can better serve eventing in Queensland.

## Increasing membership by competitions and committee initiatives

2014 saw 2541 horse and rider combinations compete at 20 One Day events in Queensland. This equates to 17% of competitors across Australia. Of the 2541, 11 competed at Three Star Level (CNC & CIC); 77 at Two Star (CNC & CIC); 216 at One Star (CNC, CCI & CIC); 445 at EvA105 (Snr & Jnr); 597 at EvA95 (Snr & Jnr); 814 at EvA80 (Snr & Jnr); 290 at EvA60 (Snr & Jnr); 77 in Come and Try Classes; and 14 in Intermediate or Combined Training Classes. In addition 374 Queensland Horse and Rider combinations travelled interstate to compete at 23 One Day Event competitions, including 11 who made the trek to Adelaide for the Australian International Three Day Event. We

congratulate all our rders, and especially those that tasted success, both locally and interstate.

The committee introduced "Get Eventing" as an entry level program to encourage new competitors. Using Development Grant funding combined with a co-contribution from the committee a number of clubs around the state held very successful clinics for aspiring eventers.

#### Officials Development

On the 8<sup>th</sup> and 9<sup>th</sup> November a Technical Delegate and Course Designers course was held at Fig Tree Pocket. The course was conducted by Brendan Croese and was attended by over 40 participants from both the EQ and Pony Club community. The development of new officials is so critical to the future success of our sport.

#### **Major Events**

The Eventing State Championships were conducted by Fig Tree Pocket in October. The 178 starters were presented with a challenging upgraded cross country course. The CCI 2\*, cosponsored by Eventing Queensland, was won by Olympian Rebel Morrow with 5<sup>th</sup> place getter Kirsty Douglas going on to win the CCI 2\* class at the Adelaide International 3 Day Event in November.

The Queensland International 3 Day Event was held in August at Morgan Park, Warwick. With classes available through to CIC 3\* the 160 starters were presented with the opportunity to compete at the elite level of competition. The Queensland Team were successful in claiming the trophy for State of Origin at this year's event.

#### **Elite Level Incentive**

To promote competition at the elite level the Eventing Committee, this year, offered clubs a \$1,000 contribution towards running a CIC 3\* class at any of their events.

#### **New Clubs and Venues**

2014 saw the introduction of a new club and venue at Noosa. The Noosa Equestrian Centre held three events during the year with classes on offer up to CNC 2\* level. With the number of starters growing from 74 to 110 over the three events and with a challenging cross country course on offer this venue has grown in popularity with competitors.

With the eventual sale of the Kooralbyn resort in the second half of the year a new committee was formed by the Kooralbyn Equestrian Group. Following extensive negotiations with the new owners and a large investment in getting the grounds rebuilt, plans are in place to hold their first event over the Faster 2015 weekend.

#### Communication

The On Course Magazine continues to be the main source of communication to the Eventing community. Clubs and organising committees receive regular electronic updates via the Club Update e-mail that goes out following each monthly Sports Committee meeting. The introduction of the E-News Newsletter has proved to be well received. This newsletter provides "instant updates" to competitors of issues of importance.

The committee would like to thank Deb Postle and Pam McGarrigle for continuing to act as Administrators for the Facebook page in 2014. Social Media continues to be well followed, and a growing source of information.

#### **Operational Support**

The committee have applied for grants to purchase two new dressage arenas and synchronised timing equipment. These will be available to clubs free of charge and stored in the Eventing Queensland trailer which has been refurbished, thanks to Evan Godsall, of Bayside Springs.

#### Many thanks

The committee wishes to express its gratitude to the organising committees, their many helpers and valued volunteers for maintaining this great sport. We also thank most sincerely our small band of hard working, friendly and professional officials, without whom this sport would falter. Thanks also to the riders and their supporters, without whom we do not have a sport.

## Interschool Queensland mission statement "to develop the individual through the discipline of equestrian sport"

2014 was another busy year for Interschool committees and riders. We have a rider base of approximately 589 riders from 160 primary and secondary schools across the State. The continuing growth of our membership of riders and participating schools has been very encouraging and has increased the profile of our sport in the school community.

Over the past 12 months our notable achievements have been:-

- Continued increase of growth in membership
- Continued increase in the number of competitions run by Schools and tag on days with EQ Clubs
- 2014 saw a growing interest from riders in North Queensland to join Interschool competition with several new riders travelling to Maryborough to compete at the State Championships with fantastic results and even seeing 2 of them make the State Team to travel to Werribee to Nationals.
- The FNQ region has grown this year with many new members keen to make the trip to Maryborough for the Championships in June. We held a Showcase up there and a qualifying showjumping event with huge success and look forward to meeting all the new riders at Maryborough. Bowen also has a growing group of schools and riders joining EQ and IQ who are also busily gaining qualifiers ready to make the trip south to Maryborough. We are very happy with the growth in these northern regions.
- The 2014 Eventing State Championships were held at Toowoomba. Riders travelled from all over the state to attend and it was a very successful event with 111 riders and 132 horses. Approximately 234 riders and

288 horses attending our 2014 State Championships at Maryborough. Qualified riders had the opportunity to compete over 5 disciplines during the 4 days in the first week of the June-July school holidays. Again, there was a significant amount of positive feedback from sponsors, visitors and the Fraser Coast Council about the running of these State Championships which is proof of the professionalism with which the committee dealt with the organisation of the event and the actual running of the entire program.

- The Interschool National Championships were held in Werribee, Victoria during the first week of October approximately 67 riders and 74 QLD horses from 45 schools made the trip. Queensland came 2<sup>nd</sup> overall in Teams which is a huge effort as traditionally Queensland finishes 3<sup>rd</sup>.

  There were also some stand out individual
- results from riders winning championships over the course of the event.
- Continuation of the Equestrian Skills Assessment Days (One in SEQ and one in DD) to further educate riders. These days allowed riders to get part of their Introductory Horse Management Certificate Introductory and Riding Certificate free of change. 2014 saw invited Interschool teams compete at the World Cup Showjumping Event at Gatton in the Junior Teams event thanks to Showjumping Queensland.
- Interschool Queensland had a stall at the Inaugural Horse Home Show. This was a successful venture which saw some new members join EQ.

- Interschool provides a pathway to the official EA competition structure and we are continuing to work with the other sporting committees to advance this aim.
- This year was the last year IQ received sponsorship from the "Be the Influence" government campaign. Pryde's Easifeeds came aboard as a major sponsor and were a huge support in this first year of being involved with Interschool. Many thanks to Ron Major for this support. Equissage has remained a stalwart supporter of IQ and are on board again in 2015. The IQ committee are extremely grateful for the many years now of ongoing sponsorship from Lucy and her team.
- Showjumping equipment has been purchased for the DD region to add to their dressage equipment and trailer. A Trailer for the Showjump equipment is currently being manufactured.

- At the Equestrian Queensland Awards night we are proud to congratulate School of the Year – Glennie, Interschool Team of the Year – Stuartholme, (Well deserved awards for 2 hugely supportive schools), Administrator of the Year – Tracey Vardy and Service to Sport Richard King.
- On a final note may we say a special thanks to the tireless workers on the State and Regional Committees, the EQ office staff, judges, officials, volunteers and of course parents for their assistance to provide quality competition for our riders.

#### JUMPING REPORT

The Jumping Queensland Committee commenced the year with the organisation of some very good clinics with international coaches that were well supported. One clinic organised by David Manuel in conjunction with Equestrian Australia's High Performance team where we were fortunate to have Yves Houtackers come to Queensland and present us with a 2 day school. All riders who participated were very impressed with his coaching methods.

With the departure of Guy Creighton following the annual general meeting Robert Goodwin was voted on to the committee. This brings a young perspective to the committee with a great deal of knowledge on the ways the committee would like to move forward bringing the sport in Queensland on par with an international level.

Unfortunately we had the departure of our Chairperson, David Manuel in the second half of the year which left quite a big gap on our committee but we were fortunate in that Averil Hawthorne stepped into this role and has made some significant progress especially with the financial side of the committee. The committee voted Robert Moffatt onto the committee with the vacant position as he was one of our riders' representatives and Robert has already made an impact on the committee in a short period of time.

The committee appointed Shane Davidson to the position of State Junior/Young Rider coach, where Shane will work with Robert Goodwin in organising clinics for the junior/young rider squad members to attend. Our riders' reps will continue with Robert and Merrick Ubank at the helm for 2015.

Our Gatton World Cup was again a huge success with a record number of riders and horses over the 4 days has yet again been deemed the biggest ever equestrian event held in the region gaining some sponsorship from local businesses and our main sponsor with the naming rights to our world cup qualifier was Pryde's Easifeeds. Also another great sponsor this year, a first ever for an equestrian event was from the University of Queensland's Veterinary Hospital. Our world cup class attracted once again the highest number of nominations seen in Australia for the 2013/14 world cup qualifiers 40 nominations with 36 starters and a win to our very own fellow Queenslander, Paula Hamood in a very exciting jump off just tipping Merrick Ubank who took second place. We were again blessed with good weather and a great arena thanks to Cam McDonald and his team at the Gatton showground.

In 2014 the committee gave the Foxhunter Final to the Queensland Jumping club located at Caboolture who also ran our second Young Rider Tekna class. #### **VAULTING REPORT**

2014 has been an outstanding year for Queensland Vaulters. The highlight was the selection of 11 Queensland Vaulters as part of the Australian Vaulting Team at WEG 2014 in Normandy France. The Senior Squad from Fassifern Vaulting Team and Morgan Spary from Kingfisher were our representatives. The majority representation by Queensland vaulters at WEG is proof positive that the quality of Vaulting in Queensland continues to improve and we are creating opportunities for our vaulters to be the best they can on the world stage.

Our young committee has gone from strength to strength and they are excited that they have successfully bid to run the Australian National Championships in 2015. The National Vaulting Committee has watched the development of our committee and has given us a vote of confidence in the ability of the committee to run such a prestigious event. The Committee have decided to run Queensland's first CVI 2\* in conjunction with this event and they are hoping that the Queensland Equestrian Community will find time to come along and enjoy Australia's best.

The Committee has successfully met our performance targets this year, running all proposed events in the calendar along with the meeting the responsibilities of the demands for international competition. We are finding that events run by the Committee in conjunction with Clubs are proving to be the best formula. The Committee brings the experience of managing events and the clubs provide more volunteers on the ground. The formula means we are minimising the dangers of burn-out and are up skilling more volunteers.

We had 32 Queensland vaulters compete at our State Championships in July and attracted competitors from NSW, VIC and WA to the event. SA Australia hosted a CVI 3\*early in 2014 and Qld vaulters in attendance scored well. Up and coming McKeira Cumming from Ella Springs scored a 6.7 in the Junior 2\* Class. Nationals was hosted by SA in October and despite only just having returned to Australia from WEG both Kingfisher and the Fassifern travelled horses and Vaulters to the event. We had a good showing there with the Fassifern Senior Squad bringing home the National Championship trophy for the 5<sup>th</sup> year in succession and Mckeira placed 3<sup>rd</sup> in the Open Class. Once again all our Queensland Vaulters showed that we are quality performers at all levels.

The 2014 Equestrian Queensland Awards recognised Angie Deeks as Officiator of the Year and McKeira Cumming as Junior Sports Star of the Year. It is a great honour for Vaulting to be recognised by the Equestrian Queensland community and it is a testament to the passion and commitment there is in Queensland Vaulting to be deemed fit to be awarded such honours.

So to 2015, the committee's focus will be on meeting our performance targets for Queensland Vaulting and hosting the best Queensland run Australian National Championships and CVI 2\*.

My personal thanks go to all the committee members for their passion, commitment and hard work in 2014 and my thanks in advance for more of the same in 2015.

#### TREASURER'S REPORT

#### Financial Statements to 31 December 2014

Equestrian Queensland has performed well in 2014 reporting a consolidated revenue of \$1,672,899 which is approximately a 4% increase on the previous reporting period (2013: \$1,600,565). The 4% increase in revenue has been accompanied by a 3% increase in expenses (\$1,566,647 in 2014 compared to 1,510,064 in 2013) leaving total comprehensive surplus of \$106,252 compared with 2013 when it was \$90,501. This result is third consecutive surplus delivered, which is a pleasing result particularly following a deficit in 2011, which required some difficult but necessary workforce decisions to ensure the financial sustainability which is a key strategic priority.

The appointment of Red Shed in March to fulfil the financial officer function for Equestrian Queensland has proved to provide prompt and detailed reporting to assist decision makers on all committees. Byron's were also thorough and efficient in conducting the audit and their reappointment is recommended again next year.

Cash at bank levels remain healthy at \$530,132 at 31 December 2014 (2013: \$541,051) and with the equity in a much stronger position (from \$416,230 in 2013 to \$522,482 in 2014), allows 2015 to focus on maintaining the current equity position.

Equestrian Queensland funding of the subcommittees, sports development and FEI events have been increased slightly and the 2015 budget is forecast for a smaller surplus.

#### Report on the Financial Report

We have audited the accompanying financial report, being a special purpose financial report of Equestrian Queensland Inc. # NOTES TO AND FORMING PART OF THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 31 DECEMBER 2014

#### 1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

These financial statements are special purpose financial statements prepared in order to satisfy the financial report requirements of the *Associations Incorporations Act (QLD) 1981*. The Committee has determined that the Association is not a reporting entity.

The financial statements have been prepared on an accruals basis and are based on historic costs and do not take into account changing money values or, except where specifically stated, current valuations of non-current assets.

The following significant accounting policies, which are consistent with the previous period unless stated otherwise, have been adopted in the preparation of these financial statements.

#### a) Plant and equipment

Plant and equipment is carried at cost less, where applicable, any accumulated depreciation.

#### Depreciation

Depreciation has been charged on plant and equipment at rates assessed to match the cost of each of the assets over their economic life. Depreciation rates vary from 10% to 30% and are applied on a diminishing value basis.

The assets' residual values and useful lives are reviewed, and adjusted if appropriate, at the end of each reporting period.

Gains and losses on disposals are determined by comparing proceeds with the carrying amount. These gains or losses are included in the statement of profit or loss and other comprehensive income.

#### b) Cash and cash equivalents

For purposes of the statement of cash flows, cash includes deposits at call which are readily convertible to cash on hand and which are used in the cash management function on a day to day basis, net of outstanding bank overdrafts.

#### c) Financial instruments

#### Recognition

Financial instruments are initially measured at cost on trade date, which includes transaction costs, when the related contractual rights or obligations exist. Subsequent to initial recognition these instruments are measured as set out below:

#### Financial assets at fair value through profit and loss

A financial asset is classified in this category if acquired principally for the purpose of selling in the short term or if so designated by management. Derivatives are also categorised as held for trading unless they are designated as hedges. Realised and unrealised gains and losses arising from changes in the fair value of these assets are included in the statement of profit or loss and other comprehensive income.

#### I oans and receivables

Loans and receivables are non – derivative financial assets with fixed or determinable payments that are not quoted in an active market and are stated at amortised cost using the effective interest rate method.

#### Held – to – maturity investments

These investments have fixed maturities, and it is the entity's intention to hold these investments to maturity. Any held – to – maturity investments held by the entity are stated at amortised cost using the effective interest rate method.

#### Available - for - sale financial assets

Available – for – sale financial assets include any financial assets not included in the above categories. Available – for –sale financial assets are reflected at fair value. Unrealised gains and losses arising from changes in fair value are recognised as other comprehensive income.

#### Financial liabilities

Non – derivative financial liabilities are recognised at amortised cost, comprising original debt less principal payments and amortisation.

#### Fair Value

Fair value is determined based on current bid prices for all quoted investments. Valuation techniques are applied to determine the fair value for all unlisted securities, including recent arm's length transactions, reference to similar instruments and option pricing models.

#### Impairment

At the end of each reporting period, the entity assesses whether there is objective evidence that a financial instrument has been impaired. In the case of available – for sale financial instruments, a prolonged decline in the value of the instrument is considered to determine whether impairment has arisen. Impairment losses are recognised in the statement of profit or loss and other comprehensive income.

#### d) Impairment of assets

At the end of each reporting period, the entity reviews the carrying values of its tangible and intangible assets to determine whether there is any indication that those assets have been impaired. If such an indication exists, the recoverable amount of the asset, being the higher of the asset's fair value less costs to sell and value in use, is compared to the asset's carrying value. Any excess of the asset's carrying value over its recoverable amount is expensed to the statement of profit or loss and other comprehensive income.

Impairment testing is performed annually for goodwill and intangible assets with indefinite lives. Where it is not possible to estimate the recoverable amount of an individual asset, the entity estimates the recoverable amount of the cash – generating unit to which the asset belongs.

#### e) Income Tax

No provision is made for income tax as the Committee considers the Association to be exempt from income tax pursuant to Section 50.5 of *The Income Tax Assessment Act 1997*.

#### f) Employee entitlements

Liabilities for wages, salaries and annual leave are recognised, and are measured as the amount unpaid at the reporting date at current pay rates in respect of employees' services up to that date.

A liability for long service leave is recognised, and its measured as the value of unconditional entitlements in respect of service periods exceeding five years, at pay rates applicable at the end of each reporting period.

#### g) Revenue

Revenue is measured at the fair value of the consideration received or receivable.

Interest revenue is recognised using the effective interest rate method.

Membership income is recognised as revenue over the membership period. Unearned membership income in the statement of financial position represents amounts collected for memberships which have not yet been earned.

Grant income received from Government is brought to account when received except where unspent amounts are refundable, in which case the funding is recognised over the period of expenditure.

#### h) Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office. In these circumstances the GST is recognised as part of the cost of acquisition of the asset or as part of an item of the expense. Receivables and payables in the statement of financial positions are shown inclusive of GST.

Cash flows are presented in the statement of cash flows on a gross basis, except for the GST component of investing and financing activities, which are disclosed as operating cash flows.

#### i) Adoption of New and revised Accounting Standards

There are no accounting standards issued between the previous financial statements and the current reporting date that have a material impact in the Association.

#### Critical estimates and judgements

The committee evaluate estimates and judgements incorporated into the financial report based on historical knowledge and best available current information. Estimates assume a reasonable expectation of future events and are based on current trends and economic data, obtained externally and within the Association.

There were no significant estimates or judgements used by the committee in the preparation of these financial statements.
