1. A Lease Notification will only be accepted where the **Owner/s & Lessee /s are current members of the EA.**
2. A Lease Notification Form must be forwarded to the **Owner's EA State Office** within 30 days of the "Start Date"
3. A Lease Notification Form must have indicated a "Start Date" and "Expiry Date"
4. Under all circumstances (including the issue of fines and penalties), the Lessee will be considered the responsible party
5. The horse's **ORIGINAL CERTIFICATE OF REGISTRATION MUST BE SUBMITTED** with this Lease Notification Form. The Certificate of Registration will be retained in the office for the duration, and lease details recorded, the EA will forward a new Certificate to the lessee.
6. The ORIGINAL LEASE NOTIFICATION will only be accepted – *no photocopies or faxes.*
7. **It is highly recommended that you have a Legal Lease Agreement (contract) drawn up between both parties to prevent any legal issues at a later date.**
8. Both parties must notify the EA in writing on early termination of the lease.
9. Incomplete applications will be returned.
