# **GENERAL INFORMATION**

The Brisbane CDI Organising Committee would like to thank you for your entry and wish you the very best of luck at the event. Please read through the following important information regarding the Brisbane CDI. Regular updates will be posted on the CDI web page and on our Facebook page (search Brisbane CDI).

### **QSEC IS A GLASS FREE VENUE**

As users of this great venue we need to observe and comply with the laws that the venue is run under, which are the same laws as other large sporting venues in Qld, such as Suncorp Stadium and the Gabba. If you bring glass onto the venue in your vehicles, then that's where it needs to remain – **DO NOT** place empty bottles in the QSEC rubbish bins – take them home with you. There are large fines for people who do not abide by these rules, and as these rules have been flaunted by users of the venue, spot checks have started to be carried out.

### FACILITIES

We request that competitors take the utmost care in looking after the wonderful facilities that are being provided at QSEC. Please take pride in this fantastic venue and keep the toilets and amenities block clean. Recycling bins are located throughout the venue and we request that you place your rubbish in the appropriate bin. Please make yourself familiar with the QSEC Camping & Stable Rules and Regulations: <u>https://www.qsec.com.au/files/assets/qsec/forms/camping-and-stable-rules.pdf</u>

The indoor arena precinct is a non BYO alcohol area – that is, you can only consume alcohol that has been purchased at the bar at the indoor arena.

### DOGS

Dogs are permitted in the stable complex **ONLY**. Dogs **ARE NOT PERMITTED** at the indoor arena, the outdoor arenas or in the trade village. All dogs at all times must be secured or on a leash that is no longer than 1 metre in length. **Do not bring dangerous dogs to this event.** 

#### BIOSECURITY

Qld biosecurity legislation requires that we must all keep Movement Records when we take our horses somewhere. A Movement Record can take many forms – it can be a written note in a diary, a horse health declaration form, a note in your smart phone, etc. It needs to record the date of the horse movement, a description of the horse, the property of origin (including PIC), where you are going (including PIC), and who completed the record. You are required to keep these records for 2 years.

The Horse Health Declaration form that you will be required to submit on arrival at the Brisbane CDI can be your Movement Record, however, as we require you to submit your horse health dec to us, you will need to take a copy of the form, i.e. photo with your phone. You will also need to create a Movement Record for your trip home. QSEC's PIC is QGCB1219.

#### SPRAYING FOR COMPETITORS FROM NSW, VIC OR TICK-FREE AREAS

We have arranged for an accredited stock inspector, to come to the venue on Saturday July 20 and possibly Sunday July 21 to spray horses returning to NSW, VIC or Tick Free areas. The stock inspector will help you with the paperwork. Provided you cross the border within 24 hours of being sprayed, you will not have to stop at a Treatment Facility, such as Kirra, on your way home. We hope that this will make your journey home to NSW much more stress free. The cost of spraying is being subsidised by the event, but you will be asked to pay **\$40 per horse** directly to the stock inspector (the event will pay \$30). Please have this money in cash at the time of spraying and give it to the stock inspector. Riders who are from tick free areas in Qld and would like to also have their horses sprayed at the venue are also welcome to do so. <u>ALL RIDERS WHO WISH TO HAVE THEIR HORSES SPRAYED AT THE VENUE NEED TO CONTACT LEESA MURRAY by 7</u> JULY.

#### DRAWS

National Competition Time Draws and Queensland Young Horse and Pony Championships – Round 1 Draws will be emailed to you and made available on the official Brisbane CDI web site

http://www.qld.equestrian.org.au/dressage/brisbane-cdi

Draws will be continually updated as scratchings are received.

**CDI and CPEDI competition** draws for Thursday's competition will take place on Wednesday July 17 immediately following the Horse Fitness Inspection, then each day before scheduled competition.

A **final revised** draw may be necessary the day before each competition to allow for withdrawals. The starting order will not alter and a move up system will apply. **The onus is on the competitor to confirm/check their start times the evening before the competition.** All changes will be posted on the notice board in the Riders XOXO Bubbles & Beans Marquee and will be updated on the Brisbane CDI website. We will endeavour to keep changes to a minimum.

#### DECLARATION OF STARTERS (CDI3\* GP, CPEDI 3\*, CDI-J, CDI-Y & CDI-U25)

Refer FEI Dressage Rules, Art 424

**CDI3\* GP, CDI-J, CDI-Y & CDI-U25:** Declaration of starters: must be done by midday for the following day's competitions. Riders who have not declared by midday will be considered as a starter for the competitions entered at the closing date of entries. Declarations can be made at the Event Office.

Refer FEI Para Dressage Rules, Art 8424

**CPEDI 3\*:** Declaration of starters must be done no later than 2 hours before the draw. Riders who have not declared by this time will be considered as a starter for the competitions entered at the closing date of entries.

#### WITHDRAWALS/SCRATCHINGS:

- National Competitions Refunds will be processed as per the 2019 Saddleworld Brisbane CDI Schedule.
- CDI Competitions refer to article 424 of the current FEI Dressage rules.
- Competitors wishing to withdraw at the event **MUST** complete a **Withdrawal Form** that is available at the Event Office. This is for **ALL** classes.

#### FREESTYLES & GRAND PRIX SPECIAL

**Grand Prix CDI Special & Freestyle** – all horses in the Grand Prix CDI who gain a score of 60% or more will be eligible for the Grand Prix CDI Special & Freestyle (if entered).

**CPEDI Freestyles** – all combination who achieve a minimum average score from the Team and Individual tests of 60%.

**CDI-J Freestyle** – all horses from the CDI Junior Rider Individual competition who gain a minimum score of 60% are eligible for the CDI-J Freestyle.

**CDI-Y Freestyle** – all horses from the CDI Young Rider Individual competition who gain a minimum score of 60% are eligible for the CDI-Y Freestyle.

**Grand Prix CDN Special & Freestyle** – all horses from the CDN Grand Prix who gain a score of 58% or more will be eligible to compete in the Grand Prix CDI Special & Grand Prix CDN Freestyle if nominated.

**FEI Intermediate A/B Level Freestyle** – all combinations in the Intermediate B who gain a score of 58% or more will be eligible for the FEI Intermediate A/B Level Freestyle.

**Intermediate Freestyle** – all combinations in the Intermediate 1 or Prix St Georges who gain a score of 58% or more are eligible if nominated. The top 12-15 combinations will be offered a ride.

**Advanced Freestyle** – all combinations that have entered the Advanced Freestyle have been accepted to compete.

It is preferred by our audio staff that Freestyle Music is supplied on CD. Please hand in your music to our event staff in the Volunteer's Marquee (outside the event office) by **3 PM** Wednesday, July 17. Please ensure that it is clearly labelled with the rider's name, horse's competition name, bridle number and the freestyle competition you are competing in. Please have a back-up copy available.

Time will be set aside for your music to be checked by our audio technician to ensure it is compatible with the audio system. Riders will need to specifically request to ride if they wish to practice their freestyle on their horse, except for the Grand Prix competitors. The music practice timetable will be posted on the notice board in the Riders XOXO Bubbles & Beans Marquee.

To request a time to practice your freestyle on your horse you must contact the event director, Leesa Murray by 12 noon, Wednesday, July 17.

#### **QLD YOUNG HORSE & PONY CHAMPIONSHIPS**

**Round 1** – will be ridden in groups of two for 4, 5 & 6 year olds, and one at a time for the 7 year olds, as per the draw. Tests will be commanded for 4, 5 & 6 year olds. Tests <u>will not</u> be commanded for 7 year olds.

#### Round 2 – Conditions of Eligibility:

The top 10 placed horses or ponies (including equals) from round one will go forward to the second round provided they have attained a score of no less than 6.5 (65%) in the first round. The winner of the 2<sup>nd</sup> round will be named the "Age Group" 2019 Qld Young Dressage Horse or Pony Champion.

#### YOUNG HORSE SHOWCASE with LAURA GRAVES - SATURDAY 20 JULY

The top 3 placegetters of the second round Young Horse classes for each age group, will be invited to take part in the Young Horse Showcase with Laura Graves on Saturday afternoon. This is not a competition, however, at the conclusion of the showcase, the Qld Young Horse Champions will be presented with their prize rugs.

#### **VETERINARY MATTERS**

It is compulsory for all Competitors to fill out and sign a QSEC Horse Health Declaration on arrival at the event. The form can be downloaded here:

If you are stabling at the venue, you must hand your completed form to the Stable Manager upon arrival at the venue. If you are competing at the Outdoor Arenas (Barr Oval), or are parking at the Outdoor Arena Complex, you must hand your completed form to Gear Check before you ride.

Horses entered in the **CDI-3\* Grand Prix, CPEDI 3\*, CDI-J, CDI-Y** and **CDI-U25** are required to take part in the Horse Health Arrival Inspection and the Fitness Inspection (Trot-up):

Horse Arrival Examination (Wednesday 17 July, between 1.00pm and 3.30pm) in the stable complex. Riders are to present their horses to the Vet and Steward between these times. Riders must have their EA Horse Identification Document (CDI-J, CDI-Y, CDI-U25) or FEI Passport or EA ID Document and FEI Recognition Card (CDI-3\* GP, CPEDI 3\* horses) with them to hand to officials at this time.

 Boutique Equines Polished Look Fitness Inspection (Trot-up) – Wednesday, 17 July, 4.00pm to 5.00pm. The time draw will be posted on the Brisbane CDI website and updated versions at the event in the Riders XOXO Bubbles & Beans Marquee (please check for updates).

**Riders** at **all levels** must have their horse's **EA papers** available for inspection if requested. **Swabbing** may take place. **Penalty fines** will be imposed for those who do not have their horse papers available at the event.

# Competitors are to pay for any veterinary treatment and supplies provided by Treating Vets during the event.

If you need to call a vet to attend to your horse while at the event, the Organising Committee **<u>MUST</u>** be notified.

#### STALLIONS

All stallion riders, grooms and owners must be aware of and abide by, the EA Stallion Safe Practice Policy Rules and Regulations, effective 1 July, 2018.

#### ARENA FAMILIARISATION

An arena familiarisation timetable will be posted on the CDI website and riders are permitted to ride in the specified arenas at these set times. Competitors are advised to check the notice board in the Riders XOXO Bubbles & Beans Marquee for updated times at the event.

#### **INDOOR ARENA 2**

Due to space constraints, if you are competing in Indoor Arena 2, you will need to enter the arena and start your test from inside the arena once the judge has rung the bell. This arena will have a gate opener to let you in and out.

#### **GEAR CHECK**

Under the current EA Dressage rules, it is compulsory for every horse and rider combination to have a gear check for every test they ride. The stewards will advise whether gear checks will take place before or after your test.

#### WHIPS & GEAR

A reminder that whips that do not comply with current EA rules (must not exceed 1.2m in entirety for horses, and 1.0m for ponies), will not be allowed in the **warm-up** and **competition** areas. A whip may be carried in all National Competitions.

Whips CDI Competitions: At all international events, it is forbidden to carry a whip of any kind while competing in the arena. However, the use of one whip (maximum 1.2m), in the practice area is allowed. The whip must be dropped before entering the space around the competition arena or the athlete will entail a penalty (refer Art. 430). Upon arrival on the showground, only the rider when riding, walking, leading or lunging a horse (lunge whip allowed), is allowed to carry a whip (max. 1.2m) anywhere on the showground. The groom may also walk, lead and lunge a horse as above. Other parties are allowed to carry a whip provided it is not in connection with the training of the horse.

Whips Young Horse & Pony Competitions: a whip may only be carried in the 4YO Young Horse and Young Pony competitions. Whips are not permitted in the 5YO, 6YO and 7YO competitions.

**Head Wear:** an approved helmet is to be worn in training and practice areas. Competition attire including headwear is allowed in the final warm-up arena. At all other times, an approved helmet must be worn.

**Riders in the CDIJ, CDI-Y & CDI-U25 competitions:** an approved helmet must be worn at all times when riding, and also during the Fitness Inspection (trot-up) if you are under 26 years of age.

Riders under 25 years of age: an approved safety helmet must be worn at all times.

Young Horse Competitions: an approved safety helmet must be worn at all times.

Bridle Numbers: Riders are responsible for providing bridle numbers for their horses. Allocated Bridle Numbers as per the draw must be worn whenever a horse is out of the stable, for example when grazing or training. We suggest owners have two sets of numbers on hand, one for the head collar and the other for competition. Competitors grazing horses must take extreme care and have horses under full control at all times. If grazing horses appear to be upsetting competing horses or horses under saddle, they will be asked to return to the stables. Please do not graze or lead horses close to the competition arenas when horses are competing.

#### **STABLES & CAMPING**

The Stable Complex is accessible through Gate 14, via Old Gympie Road.

**Stabling & Camping Allocation:** The stabling and camping allocation will be posted on the CDI website. Stabling and camping is controlled through the venue.

**Stable Security:** At the completion of the Fitness Inspection on Wednesday July 17 at approximately 4.30pm, a security guard will be posted at the entry to the stables and only authorised people will be admitted into the stable complex. Riders, their nominated groom and official owner/s (maximum 2 per horse) will be given a "wrist band" which must be collected when registering at the Volunteer Marquee (outside the event office), see times below. If you require more wrist bands you will need to notify Leesa Murray, event director, prior to the event. Entry to the stables will only be permitted to riders/grooms/owners who have the appropriate wrist band. All gates into the stabling complex will be locked from 4.30pm Wednesday – instructions on how to access the stable complex will be provided with the stable allocation or from the Stable Manager.

#### Horse Arrival times are restricted to day light hours only between 6.30am and 6.00pm daily.

**Cheryl Stephen** is the Stable Manager during the event. Cheryl will be onsite Monday July 15 from 9AM to 6PM, and she will be staying on site from Tuesday, July 16 through to Sunday July 21. Please contact Cheryl if you are having transport problems and delayed arrival is expected (see Handy Telephone Numbers page for phone details).

**Arrival Procedure:** Upon arrival at the stable complex you will be greeted by the Stable Manager. Cheryl will take your completed Horse Health Declaration Form from you, note your arrival date, and show you to your camping site and stables.

**Departure Procedure:** When you are ready to depart the stable complex you must notify the Stable Manager. Cheryl will inspect your stable for cleanliness, lock your stable and note your departure date.

**Note:** Please bring you own feed and water bins as these are not provided by QSEC. It is also advisable to bring your own stable cleaning tools and wheelbarrow as these are in limited supply at the venue.

**Stable Bedding:** Your stable will be pre-filled with shavings. Extra bedding in the form of Hisorb shavings can be ordered from Feedmania (see Handy Telephone Numbers page). Orders placed by 11am each day will be delivered that afternoon.

**Stable Cleaning:** with your entry you have paid a stable bond. This will be refunded post event if your stable is left clean – clean means that all bedding, feed & urine has been removed from the stable and it has been SWEPT clean (not merely scraped out with a shovel). Any damage to stables as noted by QSEC is payable by competitors and the minimum fee for damage is \$200. This fee will be charged to competitors.

**Stable Cleaning Service:** A stable cleaning service is offered by Liam Stephen for \$25 per stable. Please book and pay for this service with the Stable Manager, Cheryl Stephen.

**Competitor Day Parking:** Day parking is not available at the stable complex. Day parking is available at the Outdoor Arena Complex, accessible through Gate 15 via Old Gympie Road. This applies to all competitors regardless of which arenas your competitions are held in.

**Car Parking:** Car parking is available on site. Please follow instructions from the Centre Management staff regarding where to park your vehicles. Vehicles are not allowed in the

competition and training areas. Only accredited persons are permitted to park in the stable complex.

#### DAY YARD BOOKINGS

Day yards are available at the Outdoor Arena Complex. These are free but need to be booked to ensure that they are unlocked. Please let the event director know if you require a day yard.

#### ACCREDITATION/TICKETS

There is no General Admission Fee to the venue on Wednesday to Friday, but there is a General Admission Fee for Saturday July 20. All Riders/Grooms (1 per horse) and owners (up to 2) per horse will receive a "wrist band" on arrival at the venue. This will allow admittance to the stables at all times. Riders, grooms and owners per horse must report **in person** to collect their wrist band.

Wristbands can be collected Tuesday July 16 from 12 noon at the Riders Desk in the Volunteers Marquee.

The Riders Desk in the Volunteers Marquee (outside the event office) will be open to **issue** accreditation and Brisbane CDI show bags:

Wednesday 17 July:	9AM to 3PM
Thursday 18 July:	9AM to 3PM
Friday 19 July:	9AM to 3PM
Saturday 20 July:	9AM to 3PM

Each rider will receive a Brisbane CDI show bag with a complimentary copy of the programme booklet along with other souvenir items.

#### CATERING

Catering will be available during the day from Wednesday to Saturday.

#### **TEST PAPERS**

On completion of the competitions, competitors will be able to collect their test sheets from the Riders XOXO Bubbles & Beans Marquee.

#### PRESENTATIONS

A presentation schedule will be posted on the notice board in the Riders XOXO Bubbles & Beans Marquee. Riders are required to be neatly attired in competition attire for presentations. Presentations in the main will be unmounted and will take place in the Riders XOXO Bubbles & Beans Marquee (please check the notice board). All freestyle presentations will be mounted except for the Advanced and CPEDI freestyles which will be unmounted. We invite non-riding owners to be present at the prize giving ceremonies.

Participation in presentations is compulsory as per the Brisbane CDI Schedule. If you cannot attend presentation then you need to arrange for someone to collect your prize for you and notify the event director, Leesa Murray, before the presentation.

**Prize money** will be deposited into your nominated bank account within 14 working days of the event.

#### WELFARE OF THE HORSE – FEI CODE OF CONDUCT

The Fédération Equestre Internationale (FEI) expects all those involved in international equestrian sport to adhere to the FEI's Code of Conduct and to acknowledge and accept that at all times the welfare of the horse must be paramount and must never be subordinated to competitive or commercial influences.

- 1. At all stages during the preparation and training of competition horses, welfare must take precedence over all other demands. This includes good horse management, training methods, farriery and tack, and transportation.
- 2. Horses and competitors must be fit, competent and in good health before they are allowed to compete. This encompasses medication use, surgical procedures that threaten welfare or safety, pregnancy in mares and the misuse of aids.
- 3. Events must not prejudice horse welfare. This involves paying careful attention to the competition areas, ground surfaces, weather conditions, stabling, site safety and fitness of the horse for onward travel after the event.
- 4. Every effort must be made to ensure that horses receive proper attention after they have competed and that they are treated humanely when their competition careers are over. This covers proper veterinary care, competition injuries, euthanasia and retirement.
- 5. The FEI urges all involved with the sport to attain the highest levels of education in their areas of expertise.
