- Scores (percentages) of team members will be added together to determine team scores. The winning team will be the team with the highest total score; the second one, the next highest, etc.
- One combination at each level is required to make up a team of three riders.
- A horse and/or rider may only be represented once in each team. A rider may only compete in one team per Team competition.
- Refer to **EA Dressage Rule 10.8** for further details on open team competitions.
- Team declarations must be made to the event office no later than **5pm Wednesday September 15th**

Teams Competition entry fee: Nil

Special Awards:

- **Dressage Queensland Regional Rider Award:** This award is donated by Dressage Queensland and is designed to encourage riders travelling from regional areas of Queensland. Riders are classed as regional when they reside more than 400kms from the Brisbane CBD. (by road, shortest direct route)
The Regional Rider prize will be awarded to the highest placed regional rider based on their best two placings in any competition from Preliminary to Grand Prix, including the GP Special. Freestyles are not eligible. Riders are to nominate on the entry form if they wish to enter for this award. No entry fee is required. For a rider on multiple horses, each horse will be a separate entry. In the case of equality, the horse with the highest aggregate percentage is the winner.
- **Young Rider Awards:** Rosettes will be awarded to the highest placed Young Riders 1-6th in each national competition (excluding freestyles). There will not be separate young rider champions awarded
- **Highest Placed Pony:** Rosettes will be awarded to the highest placed pony in each national competition (excluding freestyles). There will not be separate pony champions awarded
- **Best Performed Off the Track Thoroughbred:** This award is donated by Racing Queensland.
The Best Performed Off the Track Thoroughbred will be awarded to the highest placed off the track Thoroughbred based on their best two placings in any competition from Preliminary to Grand Prix, including the GP Special. Freestyles are not eligible. Riders are to nominate on the entry form if they wish to enter for this award. No entry fee is required. Riders will be required to submit their horse's registered racing name.

Conditions of Entry

CDI W GP, CDI-Ch, CDI-P, CDI-J, CDI-Y and CDI-U25 Competitions – will be held in accordance with current **FEI Statutes, General Regulations, Veterinary Regulations and Dressage Rules**.

National Competitions – will be held in accordance with the current EA National Dressage Rules and EA General Regulations.

MEMBERSHIP & HORSE REGISTRATION

- ALL Horses, owners and riders must be **registered and financial with EA** or, if from overseas, with their National Federation. Horses must compete under their full registered name. The Organising Committee has the right to abbreviate a horse's name for printing purposes.
- Horses must have a current EA Dressage competition licence (performance card).
- **CDI W GP, CDI-Ch, CDI-P, CDI-J, CDI-Y, CDI-U25:** Riders may participate **only** under the **jurisdiction of the country with which they hold their passport**.
- **Horses taking part in the CDI W GP** must have a current FEI Passport or Official FEI recognised EA Identification Document.
- **Horses/ponies taking part in the CDI-Ch, CDI-P, CDI-J, CDI-Y, CDI-U25-:** FEI Passports are not required, an EA National ID Document or EA Horse registration papers are required. Riders must ensure that they have the appropriate documents with them at the event. Enquiries to Equestrian Australia 02 8762 7777.
- All riders and horses/ponies participating in FEI events (CDI W GP, CDI-Ch, CDI-P, CDI-J, CDI-Y, CDI-U25) **must be registered on the FEI database. Registrations must be renewed each calendar year (i.e. Jan 1 2021)**. EA collects the charges on behalf of the FEI. Registration forms are available on the EA web site. www.equestrian.org.au/forms or contact the National Office 02 8762 7777. Please note that this registration is required even if the horse/pony has an FEI Passport or EA National Identification Document. All horses/ponies and riders must be registered with the FEI BEFORE competing in any FEI sanctioned events (CDIs) in 2021. **From 2017 all horses/ponies not currently registered with the FEI are required to have an EA Passport before applying for FEI registration.**

ENTRIES & PERFORMANCE

- **Rider Age:** **CDI W – Open to riders** from the year in which they reach their **16th birthday**. **CDI-Ch:** Open to riders from the beginning of the calendar year in which they reach the age of **12** until the end of the calendar year they reach the age of **14**. **CDI-P:** Open to riders from the beginning of the calendar year in which they reach the age of **12** until the end of the calendar year they reach the age of **16**. **CDI-J:** Open to riders from the beginning of the calendar year in which they reach the age of **14** until the end of the calendar year they reach the age of **18**. **CDI-Y:** Open to riders from the beginning of the calendar year in which they reach the age of **16** until the end of the calendar year they reach the age of **21**. **CDI-U25:** Open to riders from the beginning of the calendar year in which they reach the age of **16** until the end of the calendar year they reach the age of **25**.
- **National Competitions:** entry of horses & ponies is limited to **two consecutive levels**, e.g. Advanced/Prix St Georges; Prix St Georges/Intermediate I.
- CDI entries: horses may take part in **one test per day** (FEI Dressage Rules, Art. 422) and may not start in a national competition until the day after completing their last international competition.
- **Eligibility & Performance:**
 - All qualifying performances must be from Official Competitive competitions. The qualifying period is **1 August 2020 to 1 August 2021**; performances outside of this range may be accepted at the discretion of the OC.
 - **CDIW Grand Prix:** At least two performances of 63% or higher at Grand Prix (not including GP Special or Freestyle)
 - **CDN Grand Prix:** At least one performance of 58% or higher at Grand Prix (not including GP Special or Freestyle)
 - **CDI-Ch:** At least one performance of 60% at Novice level (CDI-Ch Preliminary or Team test performances accepted)
 - **CDI-P:** At least one performance of 60% at Elementary level (CDI-P Individual or Team test performances accepted)
 - **CDI-J:** At least one performance of 60% at Medium level (CDI-J Individual or Team test performances accepted)
 - **CDI-Y:** At least one performance of 60% at PSG level (CDI-Y Individual or Team test performances accepted)
 - **CDI-U25:** At least two performances of 60% or higher at Intermediate A, Intermediate B, Intermediate II or Grand Prix.
 - **CDN Prix St George:** At least one performance of 58% or higher at Prix St George
 - **CDN Intermediate I:** At least one performance of 58% or higher at Intermediate I
 - **CDN Intermediate A/B:** At least one performance of 58% or higher at Intermediate A/B
 - **CDN Intermediate II:** At least one performance of 58% or higher at Intermediate II
 - **CDN Grand Prix:** At least one performance of 58% or higher at Grand Prix (not including GP Special or Freestyle)
 - **PE Grades I to V:** At least one performance of 60% or higher at the respective PE Grade (EA PE tests accepted)
- **Preliminary to Advanced:** Acceptance of nominations will not be conditional on submission of qualification scores. Where available, one score at the respective level should be submitted for balloting purposes in the case of competition/class oversubscription.
- Please note performance/s must have been gained in **official EA competitive competitions ONLY**. Interschool, eventing, club and participant scores will not be accepted. HC (Hors Concours) scores will not be accepted. In the event of oversubscription of a class ranking (balloting) will be based on the highest percentage at that level as submitted by close of entry.
 - Entries will be accepted on merit **or** at the discretion of the Organising Committee
 - Qualifying scores must be obtained by the nominated horse/rider combination. The OC will consider exceptions in special circumstances only.
- The **number of horses or ponies per rider per competition** may be limited.
- The Organising Committee reserves the right to allocate 'wildcard entries' at each level in exceptional circumstances for national competitions only.
- The organising committee reserves the right to accept and/or reject entries as per Article 109.4 and 116.4 in the EA General Regulations.
- Horses entered for CDI-J, CDI-Y and CDIW competitions must have a height at the withers **exceeding 149cms** including shoes.
- Ponies entered for CDI-P competition must have a height at the withers **not exceeding 149cms** including shoes and hold a current EA pony height certificate.
- Both horses and ponies are eligible for the CDI-Ch competitions.

- Ponies may enter national competitions, however there will not be separate pony placings. There will be a highest scoring pony award for each national competition, excluding freestyles.
- Ponies in the CDI-P classes or wanting to be eligible for highest scoring pony awards must hold a current height certificate and be able to produce it on request.
- **Horse/Pony Age:** Horses must be at least 5 years of age for PE, 6 years of age for CDI-Ch, CDI-P and CDI-J, 7 years of age for PSG, Int I & CDI-Y. For tests above Inter I horses must be a minimum of 8 years of age.
- **Entry Fees:** Refer page 3 & 4.
- **CDIW GP** riders may enter and ride both the GP Special and the GP Freestyle or they can opt to ride only one. Horses must qualify with a score of 60% in the GP to be eligible to ride in the GP Special or the GP Freestyle.
- **CDIW GP** riders may enter and ride up to two horses in the Grand Prix, Grand Prix Special and Grand Prix Freestyle (providing they qualify).
- **Combinations** entered in the **CDI-P, CDI-J, CDI-Y and CDI-U25** must enter all three competitions at their level.
- **Combinations** entered in the **CDI-Ch** must enter both competitions at their level.
- **Combinations** entered in the EA Preliminary to Advanced must enter both competitions at a level

- **Horse Registration Control and Veterinary Examination and Inspection all horses/ponies:** These will be carried out in accordance with current FEI Veterinary Regulations and General Regulations and Rules for Dressage Events. Horse/pony Registration control and **veterinary examination** will take place Wednesday, 15th September 2021, time to be advised with competitor information pack.
The fitness inspection (“**trot up**”) will take place on **Wednesday, 15th September**, at approx. **4.15pm**. Details will be provided with the competitor information pack. All horses/ponies entered in the CDI W GP, CDI-Ch, CDI-P, CDI-J, CDI-Y, and CDI-U25 are required to trot-up.
- **Sampling procedure for Prohibited substances** – Vet Regs, Chapter V & VI and Annex III. Horses/ponies will be subject to sampling for Prohibited Substances. If approached by the Official Veterinary Surgeon or an Official from the OC, the competitor must allow samples to be taken from their horse/pony for drug testing. Riders must have their EA documents ready to provide to officials should their horse be selected for swabbing.
- **Insurance:** All owners and competitors are personally responsible for damages to third parties caused by themselves, their employees, their agents or their animals. They are therefore strongly advised to take out a third-party insurance providing full coverage for participation in equestrian events at home and abroad, and to keep the policy up to date.
- **Veterinary & Farrier:** Services will be available on call. Contact details will be provided with the competitor information pack.

OBJECTIONS & APPEALS:

- **CDI** competitions Refer FEI Gen. Regs Art. 163, 165, 166 & 167. Must be in writing and accompanied by a deposit of 150 CHF (approx. \$220 AUD).
- **National** competitions must be in writing and accompanied by a deposit of \$150.00. Attention is drawn to Rule 1.5 of EA Dressage Rules and the current EA General Regulations.

DECLARATION OF STARTERS (CDI W GP, CDI-Ch, CDI-P, CDI-J, CDI-Y, & CDI-U25)

- **CDI:** Refer FEI Dressage Rules, Art 424
- **CDI W GP, CDI-Ch, CDI-P, CDI-J, CDI-Y & CDI-U25:** Declaration of starters: must be done by midday for the following day's competitions. Riders who have not declared by midday will be considered as a starter for the competitions entered at the closing date of entries.

TIME DRAWS

- **CDI W GP, CDI-Ch, CDI-P, CDI-J, CDI-Y, CDI-U25 Thursday competitions:** a normal draw will take place as soon as possible after the Fitness Inspection on Wednesday 16th September and will be placed on the Notice Board and also published to the web site.
- The draw for National competitions will be a normal draw and will be available at www.qld.equestrian.org.au/dressage/brisbane-cdi

WITHDRAWALS & REFUNDS

- **Refer EA rule 10.4: Withdrawals must be notified to the OC** as soon as possible. Withdrawals at the event must complete a withdrawal form available at the Event Office.
- **Refunds:** Entry fees will not be refunded after the closing date of entries unless a medical or veterinary certificate is produced **within 24 hours** of the completion of the event. In such cases, 50% of the entry fees will be retained by the OC. Entry fees will be refunded in full as soon as possible for withdrawals before the closing date of entries. Entry fees for riders on the reserve list who are not offered a start in a competition will be refunded after the event.
- **The administration fee will not be refunded under any circumstance.**

SADDLERY & EQUIPMENT

- **Identification numbers (Bridle number)** must be worn at all times when the horse is outside its stable. Please include your allocated identification number on the entry form. In the case of duplication of numbers, the OC will allocate a temporary number for this event only.
- **Whips: CDI W GP, CDI-Ch, CDI-P, CDI-J, CDI-Y & CDI-U25:** It is, under penalty of elimination, forbidden to carry a whip of any kind while competing. However, the use of one whip, with a total maximum length of **120 cm for horses or 100 cm for ponies**, in the practice area is allowed. **The whip must be dropped before entering the space around the competition arena or the athlete will be penalised (FEI Dressage Rules, Art. 428.4 & 430).** Only riders, or grooms when riding, walking or lunging a horse, are allowed to carry a whip on the show grounds.

- **National competitions: Whips are not permitted at FEI level at a State Championship.** For EA levels whips are permitted (preliminary to advanced). Whips that do not comply with current EA rules (i.e. must not exceed 120cm in entirety for horses, 100cm for ponies), will not be allowed in the **warm-up** and **competition** areas or when riding anywhere on the grounds (rule 5.6).
- **Hats and head wear:** As per current EA or FEI rules (FEI Dressage Rules, Art 427).
- **Protective headgear:** Riders aged 25 years and under must wear protective headgear at all times, including during the Fitness Inspection. Protective headgear is recommended to be worn by all riders at the Fitness Inspection.
- **Advertising and Publicity** on competitors and horses (FEI Gen. Regs. Art. 135)
- **Fly Hoods:** EA rules apply for National competitions; FEI rules apply for CDI W, CDI-Ch, CDI-P, CDI-J, CDI-Y and CDI-U25 competitions. Refer EA/FEI rules for details.

FREESTYLES & GRAND PRIX SPECIAL

- **Advanced Freestyle:** The top 12 (AAOR and Open) combined percentages from the **Advanced 5B & 5C** qualify to ride the Advanced Freestyle (if entered).
- **Intermediate Freestyle:** The top 12-15 placegetters in the Open Intermediate I (if entered) qualify to ride the Intermediate Freestyle however a horse must earn a minimum score of **58%** in the qualifying competition (Inter I) to be eligible. The Organising Committee is free to invite the best in the AAOR Intermediate I to make up numbers, provided they have met the minimum score.
- **CDI W Grand Prix Freestyle:** the top 15 placegetters in the CDIW Grand Prix qualify however a horse must earn a minimum average score of **60%** in the CDIWGP to qualify.
- **CDI W Grand Prix Special:** (same conditions for CDI W Grand Prix Freestyle).
- **FEI Intermediate A/B Level Freestyle:** The top 6-8 combinations in the Open Intermediate B (if entered) which have scored **58%** or more will be eligible. The Organising Committee is free to invite the best in the AAOR Intermediate B to make up numbers, provided they have met the minimum score.
- **CDN Grand Prix Freestyle:** The top 6-8 combinations in the CDN Grand Prix (if entered) which have scored **58%** or more will be eligible
- **CDN Grand Prix Special** (same conditions for CDN Grand Prix Freestyle).
- **CDI-P Freestyle:** Compulsory for the top 12 combinations from the Pony Rider Individual competition which have scored a minimum score of **60%** in the CDI-P Individual to be eligible.
- **CDI-J Freestyle:** Compulsory for the top 12 combinations from the Junior Rider Individual competition which have scored a minimum score of **60%** in the CDI-J Individual to be eligible.
- **CDI-Y Freestyle:** Compulsory for the top 12 combinations from the Young Rider Individual competition which have scored a minimum score of **60%** in the CDI-Y Individual competition to be eligible.
- **GP CDI-U25 Freestyle:** Compulsory for the top 6 combinations from the CDI-U25 Grand Prix competition which have scored a minimum score of **60%** in the CDI-U25 Grand Prix competition to be eligible.
- Freestyle Music to be submitted prior to the event via a Dropbox link. There will be a timetable for Freestyle music testing.
- **Bond** – A bond of \$100 for competitors who nominate to ride in the freestyles is payable at time of nomination. This bond is fully refundable upon completion of your freestyle ride and after the conclusion of the event; or on the receipt of the veterinarian/doctor's certificate, if scratching.
- Entry fees and bond will be refunded for those who enter and do not qualify for the Freestyle.

PRESENTATIONS

- **Presentations** will be **unmounted** except for the CDI-P Freestyle, CDI-J Freestyle, CDI-Y Freestyle, CDI-U25 Grand Prix Freestyle, Intermediate Freestyle, CDN Grand Prix Freestyle, CDI W Grand Prix Freestyle, Intermediate A/B Freestyle, Advanced Freestyle, - these will be **mounted**.
- Participation in prize-giving ceremonies is **compulsory**. Failure to do so entails losing the classification (sash, prize in kind, prize money FEI Dressage Rules Art.436,
- **Prize money.** Will be processed within approx. 14 working days post the event. Any outstanding debts will be deducted from **prize money**. (FEI Gen.Regs, Art. 128): **Prize money** is awarded to the **owners or lessees** of horses. Competitors **must** provide Bank Account details so that funds can be transferred into the nominated bank account.
- Due to COVID19 social distancing restrictions, the event organisers reserve the right to stagger class presentations or alter the usual format of presentations to adhere to risk assessment guidelines.

ACCREDITATION

One rider, one rider's partner, one groom per horse and two owners per horse will gain accreditation to the event – accreditation will be limited in the case of the rider's partner being the groom or owner. Please collect from the **Riders Office** outside the indoor. This pass allows daily access to the venue and stables.

STABLING

- Stables and Camping are booked through QSEC's page on Nominate.com.au: <https://nominate.com.au/stables/VenueIntroduction.aspx?vid=239>. **Stables and Camp Sites will be allocated by the OC.**
- **CDI W GP, CDI-Ch, CDI-P, CDI-J, CDI-Y & CDI-U25** - International Rules require horses to remain on the competition grounds for the duration of the event (*from the "trot-up" until the horse has finished competing*). This rule does not apply to horses taking part in National competitions.
- **All horses competing at the QSEC Indoor Complex must hire a stable. Day parking (tying to float/truck) is **not** permitted in the camping area at this event.**
- Excellent stables are available on the grounds, 3.6m x 3.6m with anti-slip rubber matting and bitumen isles. 1/3 cubic metre (6-7 wheelbarrows) of shavings is included in the stable hire fee. Stables will be pre-filled. More bedding can be ordered from Caboolture Petstock (07) 5495 3222
- Stables are charged per day, i.e. if arriving Thursday and departing Friday this is 2 days of stabling.
- All stallions are to be stabled. EA Stallion Safe Practice Rules and Regulations Policy is effective from July 1, 2018.
- A stable allocation will apply and no horses are to be moved under any circumstance.
- All horses staying overnight must be stabled.
- There is a compulsory stable bond per stable and tack room. If stables and tack rooms are not left swept clean of all bedding, manure, urine and other waste, this bond will be retained. All stables must be inspected by the Stable Manager prior to departure for a "clean pass".
- **Competitors** are responsible for paying any damages incurred to stables during the event - **minimum fee \$210.00 per panel or as determined by QSEC.**
- Private tack rooms will be allocated ONLY if sufficient spare stables are available.
- **Day Parking** (tie to float) for those competing in competitions at the outdoor arenas is permitted or you can hire a day yard. **Competitions at the outdoor arenas are Open and AAOR Preliminary, Novice and Elementary**
- **Security** will be in place for the entire stable block from Wednesday from 6pm-6am. There will be no access to non-accredited persons.
- All competitors must complete a '**Horse Health Declaration Form**' before unloading horses at QSEC. A copy of this form can be found here <https://www.qsec.com.au/files/assets/qsec/forms/mbrc-qsec-horse-health-declaration.pdf>
- **STABLE PROTOCOL: SMOKING is not permitted in the stables!** Prams, bicycles, scooters & golf buggies are not permitted in the stables (exception – vehicles used by Stable Manager & venue staff). Children under 12 must be supervised by a responsible adult at all times. For safety reasons we recommend that all persons including children wear closed footwear whilst in the stables.
- **Arrival & Departure:** The earliest horses can arrive is Monday September 13, 9.30am. Under no circumstances will riders be allowed onsite before the stable warden has arrived and set up. The latest departure from the venue is Sunday September 19 4.00pm.

CAMPING & PARKING

Powered & Unpowered Camp sites are available with good amenities available. Camp sites are booked through QSEC's page on Nominate.com.au: <https://nominate.com.au/stables/VenueIntroduction.aspx?vid=239> Camp sites will be allocated by the OC.

CATERING: Catering will be available on the grounds from Breakfast on Wednesday morning.

CALLERS: are not permitted.

DOGS: QSEC will advise closer to the time if dogs are permitted. In the event dogs are permitted they are ONLY allowed in the QSEC camping grounds. This does not include Barr Oval, the indoor precinct including the grassed area outside or carparks or within the stable blocks. Dogs MUST be kept on a lead (maximum length of 1 metre) and under control at all times. Dogs are not permitted in the shower/ toilet/laundry facilities. Any person not adhering to this guideline will be asked to leave the grounds immediately and no refund given. Please ensure that dog droppings are disposed of using the bags provided. Do not bring dangerous dogs to this event.

Indemnity: Neither the Organising Committee (Dressage Queensland), their appointed officials, Equestrian Australia or QSEC accept any liability for any accident, theft or illness to horses, riders, grooms, spectators, grounds or any person or property whatsoever. All competitors, in entering, undertake to accept this regulation.

VACCINATIONS

Strangles (*Streptococcus equi equi*) is the most contagious bacterial infection of horses in Australia. It is spread by contamination of water and feed containers, stable walls, bars and bedding (fomites). Strangles infections are very easily transmissible and young horses, old horses and stressed horses are all potentially less than 100% immunocompetent. Strangles is only one such highly infectious and contagious disease that is likely to be transmitted when horses come into contact with each other and novel environments, at competition venues.

There are no vaccination requirements to enter this event. However, we strongly recommend that tetanus and strangles vaccines are up to date for every horse attending this event. We also strongly encourage owners of horses that reside in high risk areas to vaccinate against the Hendra Virus. Riders are required to advise the Hendra vaccination status of their horses on the entry form.

Riders and owners of horses who are not currently protected against Hendra Virus should be aware that veterinarians may refuse to treat horses until an exclusion test has shown that they do not have Hendra Virus.

QUEENSLAND TICK REQUIREMENTS: Please contact **QLD DAF Call Centre:** Ph. (07) 3404 6999 or 132523 for information. Spraying arrangements for horses returning to tick free areas and NSW will be organised to allow horses to be sprayed at QSEC prior to departure.

PROPERTY IDENTIFICATION CODE: It is compulsory to provide a PIC with your entry.

QSEC Policy:

Please note QSEC has a **no glass** policy. This includes glass jars, bottles and any glass products. Only alcohol purchased at the venue can be consumed at the Indoor complex.

CODE OF CONDUCT

Code of conduct: The organising committee of the Brisbane CDI and Queensland Dressage Championships values the attendance of all riders, officials, spectators, sponsors, volunteers and supporters HOWEVER it is a condition of attendance at this event that each person present on the grounds is bound by the rules, policies and by-laws of Equestrian Australia. This includes comments made on social media. Any complaints or conflicts should be managed with respect through official channels. As per EA Disciplinary By-Laws 3(j) any other person or organisation (for example, a parent/guardian, spectator or sponsor) who or which agrees, in writing or otherwise (whether on a ticket, entry form, conditions of entry displayed at a venue etc) to be bound by these By-Laws. Any rider, parent, official or associate to be found in breach of these By-Laws will be requested to leave the venue immediately and all entry fees and prizes deemed forfeit.

Welfare of the Horse

The Fédération Equestre Internationale (FEI) expects all those involved in international equestrian sport to adhere to the FEI's Code of Conduct and to acknowledge and accept that at all times the welfare of the horse must be paramount and must never be subordinated to competitive or commercial influences.

1. At all stages during the preparation and training of competition horses, welfare must take precedence over all other demands. This includes good horse management, training methods, farriery and tack, and transportation.
2. Horses and competitors must be fit, competent and in good health before they are allowed to compete. This encompasses medication use, surgical procedures that threaten welfare or safety, pregnancy in mares and the misuse of aids.
3. Events must not prejudice horse welfare. This involves paying careful attention to the competition areas, ground surfaces, weather conditions, stabling, site safety and fitness of the horse for onward travel after the event.
4. Every effort must be made to ensure that horses receive proper attention after they have competed and that they are treated humanely when their competition careers are over. This covers proper veterinary care, competition injuries, euthanasia and retirement.
5. **The FEI urges all involved with the sport to attain the highest levels of education in their areas of expertise.**

COVID-19
