On behalf of the Board of Equestrian Queensland I extend our sincere appreciation to all members, volunteers, officials, coaches, event organisers and participants for your continued support and dedication to the sport in 2021.

At this time, I acknowledge that some of our individual members and club affiliates are doing it pretty tough following the recent weather events in Queensland and northern NSW. The resilience and commitment of our members to support each other is something that makes me very proud to be involved in the equestrian community.

I take this opportunity to sincerely thank all our members who volunteer countless hours each year to be part of our sport committees (Dressage Queensland, Jumping Queensland, Eventing Queensland, Interschool Queensland, Show Horse Queensland, Driving Queensland and Vaulting Queensland), our advisory groups (EQ Coaching Advisory Group and the EQ Next Generation Advisory Group) and all our sub committees.

Our sport could not happen without the knowledge and passion of our officials and volunteers who have continued to work together in 2021 to deliver many successful events from local training days to international level competitions. Unfortunately, as a result of COVID-19 lockdowns and border closures a number of events did need to be rescheduled throughout the year and small number of events were cancelled. On behalf of the Equestrian Queensland Board, I commend all those event organisers who no doubt had some sleepless nights as they navigated COVID-19 to get events up and running when restrictions eased.

Each year our affiliates, clubs and members put together a full calendar of events for the equestrian community to participate in and enjoy. A number of highlights included:

- The Australian Youth Dressage Championships, which incorporated the first FEI-Children tests in Australia.
- The Brisbane CDN, which was attended by over 1,500 people along with substantial social media campaign reaching over 45,000 people.
- The Gatton World Cup with 394 horses competing over four days, even though border closures prevented athletes and horses from Victoria attending.
- The Caboolture World Cup, incorporating the Australian Teams League event.
- Interschool Queensland State Championships, with 497 junior participants, 620 horses and 1,061 entries, making it the one of the largest Interschool events in recent years.
- Toowoomba Jump Club Queensland State Eventing Championships, along with national eventing competitions at Tamborine Equestrian Group, Warwick Horse Trials, Toowoomba Jump Club, Fig Tree Pocket Equestrian Club, Fraser Coast Horse Trials, Capricorn Equestrian Group and Burpengary Equestrian Centre.
- Delivery of eight Show Horse Queensland competitions and a very successful Horse of the Year show with 150 horses competing over the three days.
- The continued delivery of new Driving initiatives including the Driving Decoded series which was supported by the Queensland Racing Integrity Commission (QRIC) Equine Welfare Program.
- The planning and delivery of the 'Spring into Vaulting' event which was attend by 20 individual vaulters to re-commence the sport after COVID-19 disruptions.

In a year with many highlights, a standout was watching two Queensland athletes, Kevin McNab and Kelly Layne compete at the highest level of our sport at the Tokyo Olympic Games. Another standout was watching the amazing performance of the Queensland owned horse Romanos who through the generous support of owner Donnella Merrett was partnered with Paralympian Sharon Jarvis and as a combination finished in 10th place at the Tokyo Paralympic Games. All three performances were inspiring, and we congratulate Kevin, Kelly, Donella and Romanos on their achievements in 2021 and we wish them all continued success as we progress through 2022 and beyond.

In 2021, Equestrian Queensland has continued to deliver valued services to its members. As an organisation we continue to innovate and improve the way we do things to support our people. In 2021, Equestrian Queensland completed a detailed strategic planning process with input from all sport committees and advisory groups including the new EQ Next Generation Advisory Group. The EQ Next Generation Advisory Group was established by the Equestrian Queensland Board in 2021 and consists of members aged between 16-25 who act as a source of advice to the Board. As a result of the strategic planning process a new plan was developed to guide the sport's priorities and actions over the next three years.

In a year with challenges, I am very pleased to report that EQ has delivered an 8th consecutive year of membership growth and operating surplus for the 10th consecutive year. In 2021, Equestrian Queensland increased the amount of funding to support education of our volunteers, safety initiatives at events and overall sport development initiatives. Through effective management by the team at Equestrian Queensland and oversight by the Equestrian Queensland Board, I am pleased to advise that this will continue in 2022 with increased funding being deployed with a key focus area around facilities and surfaces.

Equestrian Queensland has been very fortunate to have a highly credentialed and collaborative Board. I extend my sincere appreciation to EQ directors Nick Ballard, Naomi Lane, Jacqui Huppert, Jane Harms, Dave Holland and Gary Lung for their support, trust and contributions over the past 12 months. I also acknowledge the significant contribution made by Jacqui Huppert, who after serving two full terms is required in accordance with the Equestrian Queensland constitution to stand down from the Board.

On behalf of the Board, I thank CEO Briston Toft and the EQ team (Samantha Duffy, Tarni Woodhead, Melinda Robinson, Jodie Daly and Olivia Ruzsicska, Sara-Jane Seery and Grace Beatty) and for their ongoing commitment to serving our members. The EQ Board is very proud of the achievements of the Equestrian Queensland team who work extremely hard to ensure Equestrian Queensland remains an industry leader for the equine community.

It has been my absolute privilege to serve as a director of Equestrian Queensland for the past three years, both as Vice Chair in 2019 and 2020 and Chair over the past 12 months. As you may be aware, I have decided not to re-nominate for election to the Equestrian Queensland Board. This was not an easy decision, but due to work and family commitments I am unable to commit to a further three-year term. I am completely confident that Equestrian Queensland is in very capable hands with the Board and staff working constructively together to achieve the best possible outcomes for the sport.

Financial Statements to 31 December 2021

I am pleased to present the Financial Statements of Equestrian Queensland for the year ended 31 December 2021. I note that the year exceeded our expectations on many levels. The Board had conservatively budgeted for a deficit on the back of COVID-19, however, we were pleased to see continued growth across all income streams throughout the year.

Total income for 2021 ended up at \$2.16m which represents an increase of 10% (2020: \$1.97m). The increase is mostly attributable to recommencement of sports as well as continued growth in memberships and horse registrations.

The consolidated result of the year was a surplus of \$111,000 which is a great result considering the conservative outlook.

EQ maintains a strong balance sheet and it's reassuring to note that the 2021 surplus has translated into increased cash reserves.

As a result, EQ is in an excellent position to continue its activities and further investment in the sport for 2022 and maintain long-term sustainability as a member-focused organisation.

Equestrian Queensland continues to apply the highest level of diligence for its membership fees. The Board has established strict governance controls to ensure all levies are invested in accordance with its original purpose.

The Board has also recommended to re-appoint our auditors Moore for the 2022 audit for adoption by the members at the 2021 AGM.

Firstly, I take this opportunity to echo the sentiments of Equestrian Queensland (EQ) Chair, Corey Keable and thank all our members for their ongoing and continuous support of equestrian sport across Queensland.

I am pleased to advise that EQ continues to grow, innovate, lead and improve. One of the many positives for our sport has been the continued collaboration between volunteers, officials, coaches, event organisers, clubs, committees and EQ to stay informed during the periods of uncertainty and deliver a full calendar of safe activities during the ongoing COVID-19 pandemic.

Our highlights for 2021 included:

- Delivery of club development, governance, safety, finance and COVID-19 forums to support our affiliated clubs and sport committees to deliver safe and compliant activities.
- Providing more than \$200,000 in direct investment through funding programs which support rider development, official and coach education, events and safety initiatives for regional clubs and affiliates.
- Supporting the recruitment, refresh or upgrade of officials in the sport through education as well as providing funding to assist individual members with travel expenses associated with attending EA/FEI recognised courses.
- Delivery of the Queensland Youth Development Camp, a multi-disciplinary youth activity in collaboration with Dressage Queensland, Eventing Queensland, Jumping Queensland, & Show Horse Queensland to provide educational opportunities for junior and young rider members both on and off their horses.
- Delivery of the EQ/ Dressage Queensland Virtual Dressage Series for the second year with over 120 entries in each of the 3 rounds.
- The launch of the new EQ Next Generation Advisory Group for members aged between 16 and 25 to act as a source of advice to the Board about opportunities to engage, connect and support young people in equestrian sport.
- Partnering with Racing Queensland and the Queensland Off-The-Track Board as part of the Queensland Off-The-Track Program to provide opportunities for EA accredited coaches to provide subsidised lessons for new owners of retired Standardbred and Thoroughbred horses.
- The launch of the new 'EQ Volunteer Thank U Series' to provide an opportunity to introduce and recognise our dedicated volunteers from the equestrian community.
- Supporting participation of clubs and the development of grassroots riders through the delivery of eight EQ Leaderboards and the Interclub Challenge.
- Partnering with Pony Club Queensland to deliver the Interschool Queensland & Pony Club Queensland Show Jumping Invitational event at the Toowoomba Showground in November 2021.
- Delivery and promotion of the EQ Code of Conduct video.
- Launch of the new EQ Animated Series and Characters to promote memberships and the equestrian pathways.

Membership and Finance:

In 2021, EQ delivered another year of membership growth (our 8th consecutive year) and a consolidated operating surplus (our 10th consecutive year). It is very pleasing to report that all membership categories (competitor, participant, supporter, recreational, junior and senior) increased in 2021 with participant level membership with EQ up 20% in 2021. Our total membership for 2021 was 4,286 members which has increased by over 8% from 2020. As per the report from EQ Treasurer, Naomi Lane, EQ is in a very strong position to leverage its success to continue delivering increased participation and education opportunities for members along with deploying additional funding to support safety and equestrian facility improvement initiatives.

With the current EQ Strategic Plan 2018-2021 coming to an end in 2021, EQ commenced a strategic planning process in March 2021 to guide the sport forward over the next three years. The process involved a detailed review of feedback from the 2020 & 2021 EQ Member Surveys along with strategic planning workshops with the EQ Next Generation Advisory Group, EQ Coaching Advisory Group, Dressage Queensland, Eventing Queensland, Jumping Queensland, Interschool Queensland, Show Horse Queensland, Vaulting Queensland and Driving Queensland.

Through the consultation process, common themes around pathways, culture and information were identified along with a key focus area around safety.

The new EQ Strategic Plan 2022 – 2025 centres the organisations priorities and strategies around:

- **Excellence in equestrian sport**
- **Pathways for all participants**
- **Sustainability of the sport**
- **Governance and Culture**

This important strategic planning document defines clear priorities and common themes to support EQ to continue to raise the standard of the sport, increase participation opportunities, maintain financial sustainability and improve value for all members in the years ahead as we eagerly look forward to the 2032 Olympic and Paralympic Games in Queensland.

I wish to take the opportunity to acknowledge the EQ Board, Corey Keable, Nicholas Ballard, Naomi Lane, Jacqui Huppert, Jane Harms, Dave Holland and Gary Lung for their support and dedication to improving equestrian sport in Queensland. I also extend on behalf of the entire team at EQ our appreciation to the hard working volunteers on all the EQ sport committees and advisory groups. We are very fortunate to have such a committed group of volunteers who dedicate their time to provide a full calendar of activities each year for benefit of all members.

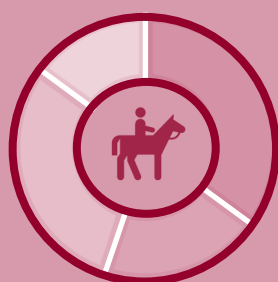
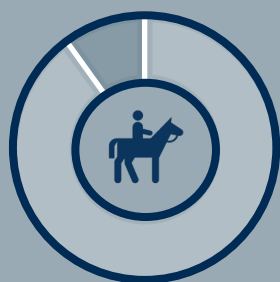

2021 Equestrian Queensland Funds Distribution



Sport Development / Rider Development

EQ provided \$30,119 to affiliated Clubs and EQ Sport Committees to support member development, growth & participation across all disciplines through rider development clinics or protocol days. EQ also provided \$3,200 to regional affiliated Clubs to assist with Judges travelling expenses to support development in Dressage, Eventing and Jumping.



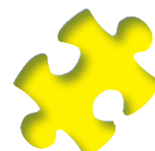
Officials Education

EQ provided \$19,662 to support the development of EA accredited Officials by providing funds to assist with the delivery of accreditation courses and funds to assist with travel expenses associated with officials attending EA/FEI courses.



Safety & Equipment

EQ provided \$10,101 to assist regional affiliated Clubs with improving safety standards.



Coaching Education

EQ provided \$5,410 to support the growth and development of EA Coaches, SSTA's and Coach Educators through the delivery of EA accreditation courses and assessment opportunities such as the EQ Coaching Intensive Clinic.



High Performance

EQ provided \$14,000 to support the development of elite athletes through EQ Sport Committee high performance programs.



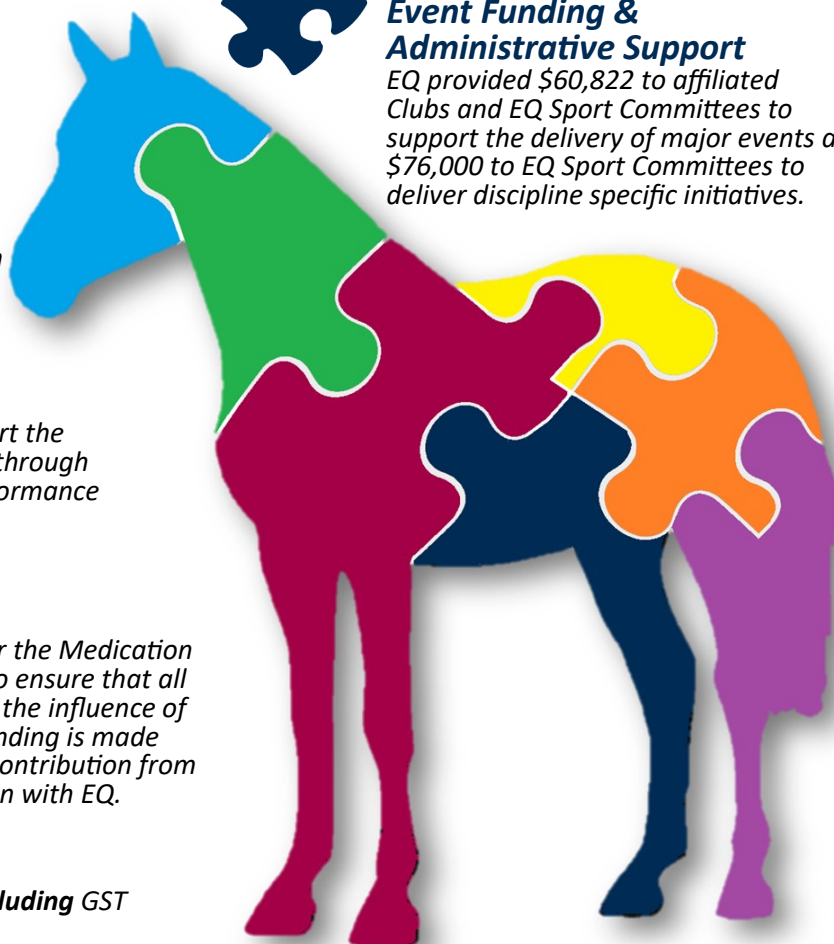
Medication Control

EQ provided \$26,023 to deliver the Medication Control Program (swabbing) to ensure that all horses are competing without the influence of prohibited substances. This funding is made available through a financial contribution from each new life horse registration with EQ.



Event Funding & Administrative Support

EQ provided \$60,822 to affiliated Clubs and EQ Sport Committees to support the delivery of major events and \$76,000 to EQ Sport Committees to deliver discipline specific initiatives.

COACHING ADVISORY GROUP

Benjamin Franklin once said “Tell me and I forget, teach me and I remember. Involve me and I learn.”

Looking back on 2021, the Equestrian Queensland Coaching Advisory Group (CAG) have been passionate in giving coaches opportunities to be involved in professional development to further develop skills and knowledge.

At the beginning of 2021 we said farewell to outgoing CAG members, Geraldine Montfrans-Eady, Sharyn Ross and Irene Bakels-Noreen and welcomed, Grant Paddison, Karen Crommelin and Sasha Ulasowski. Along with Trudy Dougall and Darryn Fedrick, the group brings to the fore a wide range of experience in education and coaching.

The year started off strong with an update and professional development day being held at Fig Tree Pocket Equestrian Centre in April. The day was well attended with coaches involved in a variety of workshops with topics including equestrian Mindset and Success with Tanja Mitton, Optimal Physical and Mental Health by Danielle Keogh, as well as Social Media and Marketing by Tarni Woodhead. Other topics included Insurance and EA Safety and Risk Management. Darryn Fedrick presented a Vaulting Masterclass with an excellent demonstration showing the requirements of the Vaulting horse and lunging techniques used. One of the highlights was the Driving Masterclass presented by Bob Edwards EA Driving Course Designer and EA Coach Level 2 Driving specialist and EA Technical Delegate Level 1, Irene Bakels-Noreen EA Coach Level 2 Dressage Specialist and EA Coach Educator and assisted by Corby Cunningham EA Introductory Driving Coach.

April also saw eleven coaching candidates over two days put through their paces during the EQ Coaching Intensive Clinic. These clinics are proving to be very successful as an alternate method for coaches to be given the opportunity to achieve their coaching certificate under the watchful eye of coach educators. While this certainly does not replace the traditional pathway, it has proven popular for those trainees that prefer the two-day format.

Unfortunately, our second EQ Coaching Intensive Clinic, Coach Educator and Skill Specific Trainer and assessor workshops had to be cancelled as we were unable to bring our interstate assessor and presenter to Queensland. This has been rescheduled for 2022.

Two presentations were also held over the year via Zoom. “Getting Started” an information evening for coaches starting on their Coaching Pathway and “The Next Step” for those coaches looking at moving on toward their Level 2 accreditation. Both were well attended and gave coaches valuable information on the competency-based trainee process.

One of the incentives that the CAG has been working on is how best to assist our regional coaches. Early in the year a zoom meeting was held to identify how the regional coaches and trainees could be assisted. Grant Paddison has taken on the role of regional contact and planning is currently underway for a regional coaches’ workshop in 2022.

Our Queensland coaches have been recognised in the “EA coach of the Month”. A regular series on the Equestrian Australia website, it is a way of highlighting the Equestrian Australia Coaches and Educators who work with dedication all over Australia. In Queensland, it provides a way for EA Queensland coaches to acknowledge and recognise other Queensland coaches, doing something great in the industry.

One of the highlights for the year was the professional development day run at the beautiful Belli Park in conjunction with “Horses and Humans”. The Developing Coaching Skills – Coaching Equestrian Athletes with a Disability workshop provided information for EA Accredited Coaches to be better skilled in assisting riders of all abilities in an inclusive coaching environment. It was an educational day with great presenters focusing on a “Team” approach and the importance of open communication between ALL specialists that help the rider and horse. An interactive workshop and much was learnt by all whom attended.

There is more planning being done to deliver additional workshops in 2022 to cover other educational topics associated with Coaching.

Another wonderful incentive for our qualified coaches has been OTT coach recognition from Queensland Racing. The Off the Track lessons program has been extremely popular with many riders taking up the program and gaining valuable assistance in the re-education of their OTT Thoroughbred.

Planning is underway for an EA Level 3 accreditation. This will be run by Equestrian Australia with a number of Queensland level two coaches putting in an expression of interest. It is great news to see another level three accreditation taking place.

There has been inroads made on the vaulting and carriage driving syllabuses and hopefully these will be able to be finalised in 2022.

A final thanks must be delivered to the staff of Equestrian Queensland who provide us with so much support. EQ subsidise many of the costs associated with delivering these workshops and intensive clinics and the work they do behind the scenes cannot be underestimated. Without their help we would not be able to deliver the workshops and intensive clinics that we set to deliver.

DRESSAGE QUEENSLAND Report

2021 was another strange year, with the added difficulty of snap lockdowns. Dressage Queensland found itself in a situation where a number of our planned member activities were cancelled or postponed at the very last minute due to these lockdowns. This was both frustrating and deflating for event organisers.

Despite the challenges we forged ahead and managed to run many wonderful and well supported events. The Dressage Queensland Riders Subcommittee (DQRSC) ran nearly a full complement of their usual competition schedule, sponsored by The Browband Bar. This included protocol days, arena training sessions, competitions for all levels and a massive 2* Championship. The DQRSC also revived the Futurity competitions for up-and-coming horses at novice, medium, Prix St Georges and Grand Prix, which was sponsored by Equine Edge Rehabilitation. This concept was very well supported and will see a return in 2022.

Despite the best efforts of the committee, The Saddlefitter Brisbane CDI was again downgraded to a CDN due to both international and state border closures leaving no other option. Even so, the event was still of very high quality and well attended by Queensland riders. Entries were unprecedentedly high across all levels. Victorian-based Equestrian Life, worked with the committee to utilise remote live streaming to bring the event to dressage enthusiasts who were unable to attend the event. The Saturday entertainment day was popular with spectators, and the professional video footage from Unicorn Productions was very popular on social media.

Unfortunately due to a snap lockdown in the days leading into the Australian Youth Dressage Championship, this event had to be postponed from its original date and borders remained closed to interstate competitors for the rescheduled date. This was disappointing, however, the event committee were thrilled with the support from local riders, sponsors and officials, and the event was a wonderful showcase of some seriously good up-and-coming talent. The event also offered the FEI-Children tests for the first time ever in Australia, and these classes were well supported and enjoyed by the competitors.

The Virtual Dressage series continued in 2021 and we love to see the number of regional riders engaging in this platform. We also piloted a Foundation Series version of the Amateur Rider division to try and support and encourage less experienced riders to step into the ranks of official competition. We were delighted with the finalists in this series, with riders who wouldn't normally feature in our end of year awards stepping out to receive their prizes, however it created a lot of extra work for regional championship organisers and this year we will bring it back to a club-based official series and try to simplify the workload for Star Championship event organisers.

Despite our best efforts and frequently changing management putting us back at square one, we have been unable as yet to come up with a suitable solution for arena upgrades at QSEC. With support from Equestrian Queensland, we will continue to lobby for arena improvements and hope to eventually see some movement in this space.

2021 began with hope that we would return to a modicum of normal. At the start of the year the committee consisted of: Rebecca Jenkins, Nik Koroloff, Madeleine Graham, Frances Graham, Graeme Watts and Lisa Holland. Throughout the year we welcomed Terri Langdon, Trevor Hyatt, Nigel Dunmore and Christine Bradfield onto the committee.

Our Jumping Team selectors this past year were Graeme Watts, Becky Jenkins and Christine Bradfield with Judy Jackson as a reserve selector. Once again, we are fortunate to have Graeme Watts giving us a voice as Chair of the National Jumping Committee and Stuart Jenkins representing our riders as the National Riders Representative on the National Jumping Committee.

Jumping Queensland ran a very successful Junior and Young Rider squad clinic on 5/6 June, hosted at Kolora Lodge in Brisbane. Squad members were offered an opportunity to join the clinic, with additional places offered by EOI to junior and young riders, with twelve places in total. - An Olympic evening with Glynis Nunn and Jane Harms, who spoke to the riders about the sacrifices that are made to represent your country at an Olympic level.

We thank Lisa Holland for organising this clinic.

A new World Cup sub committee was formed to lessen the work load on the Jumping Queensland committee. This sub committee consisted of Christine Bradfield, Graeme Watts, Judy Jackson, Becky Jenkins, Lisa Holland, Katie Mendl and Jedd Johnstone. Gatton World Cup was moved forward to June and we were all happy to see the efforts of a small committee come to fruition with the event going ahead. With a MER (Minimum Eligibility Requirement) on offer for WEG in 2022, WC entries were excellent and of a very high standard. A Youth Olympics COC (Certificate of Competency) class was also offered, our Queensland Young Riders had an opportunity to showcase their talents for the National selectors. The Graeme Watts designed courses were testing and provided a wonderful showcase of show jumping to the world stage via livestream. Overall, the event was a huge success.

Jumping Queensland ran several EA Course Builder and EA Judge Workshops including EA Level 1 courses across the state. Terri Langdon took on the role of organising Officials Clinics and liaising with existing and new Officials. She has embraced the role with enthusiasm and it's wonderful to see her mentoring the new officials.

Jumping Queensland supports events each year through funding to help ease the financial burden on event organisers. Last year we supported Caboolture World Cup (it was wonderful to see the high standard of show jumping continue over the David Shephard built courses), Gympie Show who held the Jumping Queensland State Championships and the Queensland Indoor Championships. A number of the committee members also volunteered their time to help at the Queensland Indoor Championships in September.

Our biggest concern heading into 2022 is the impact COVID restrictions are having on the Queensland Agricultural Shows. Due to a COVID vaccination mandate implemented by the Queensland Government, many Queensland Ag Shows have already cancelled or postponed their 2022 events. Queensland show jump riders have always heavily supported show jumping at Agricultural Shows and it is vitally important that we find a way to help support these shows going forward.

Jumping Queensland thanks Lisa Holland, Frances Graham and Graeme Watts for their wonderful contribution to the Jumping Queensland committee and we welcome new members Christine Bradfield and Nigel Dunmore.

Contributing to a committee brings many rewards, while also occasionally presenting challenges both personally and professionally. It is overwhelmingly positive to welcome committee members from all walks of life with varied experiences and points of view to offer, providing diverse representation within the committee to the equestrian membership. We note that at times this diversity can strain relations when that same group of personalities search to find a mutually beneficial path forward. Interschool enjoyed another very positive and strong year that was fortunately reasonably unaffected by COVID. The 2021 calendar was full, giving participants in our five disciplines ample opportunity to qualify for State Champs in June and July. The IQ committee worked cohesively for the benefit of the sport, and we thank them for their substantial input throughout the year. All participants benefited from their continued interest, timeless effort and fresh initiatives. We continue to develop and our membership is growing. We sincerely thank Briston Toft and the EQ team, Corey Keable and the EQ Board in supporting our endeavours. We acknowledge your time, input and ongoing interest in IQ and its development.

Due to the continuing effects of COVID, members of IQ committee recognised opportunities to deliver innovative new events for IQ riders:

The IQ Dressage Convenor - Kirstie Ferguson, introduced a virtual event – The Hygain Virtual Interschool Challenge. This included all Australian and NZ riders, with classes and tests available to riders from the 5 Interschool disciplines. This was delivered in November and was received very positively by the 99 riders including 27 from NZ. Thank you to EQ office and the Dressage judges for their support with this special event.

Our Show Jumping Convenor, Patrick Lowe and our CT/Eventing Convenor, Monique Searle, gave all riders who jump the opportunity to represent their state. Not only did IQ lose their Nationals but the Pony Club riders also lost their bi-annual national competition. The Greg Grant Saddlery IQ & PCE Invitational Show Jumping Event was held at Toowoomba as an invitational event for the IQ State Team and Pony Club Queensland. A very competitive weekend was had by all with a great atmosphere that cultivated a stronger relationship between the two associations. We hope that the event will have an annual place in the calendar. The event hosted 62 riders and 75 horses, a sincere thankyou to all the event sponsors.

Helmet Tagging – this was implemented in 2021 successfully at all IQ events, across all disciplines. Thank you to everyone who assisted with the tagging process.

Equestrian Skills Program – involves Introductory Horse Management and Riding Skills and the assessment will start at SEQ Regionals in 2022. There are 21 statewide riders enrolled and are taking part in online and face to face sessions and assessments. Thank you to Melinda Robinson and EQ for their work on this initiative for our riders.

Successful Regional events were conducted by Darling Downs, Wide Bay and South East Queensland event sub-committees. Thank you to these organisers, all these events saw an increase in nominations. In November we were very pleased to hear about the return of a Capricornia Regional Committee. We wish them every success for their first regional event at Mt Larcom Showgrounds 18 – 20 March 2022.

2021 Hygain Interschool Queensland State Championships held at Maryborough saw increased nominations from 2020 with full nominations across Dressage, Jumping and Show Horse disciplines. There were 257 riders / 277 horses / 800 + nominations (before scratchings). Extra classes were added for Dressage and Show Jumping to accommodate nominations.

2021 Hygain Interschool Queensland State Championships held at Warwick included the disciplines of Eventing and Combined Training. There were 110 riders / 129 horses / 174 nominations (before scratchings). Thank you to Tracey Sexton for being the OC for this event especially in the trying weather conditions.

As our sport continues to grow, there are now five disciplines to manage. We currently split these over six days at two different venues and dates. With our continued growth and rider nominations, we find that venues cannot support us adequately with no venue that has adequate overall facilities.

2021and COVID was still with us!

Luckily our committee has worked through these challenges before and we launched into planning mode to provide a full year of events and clinic opportunities for our members.

With the cancellation of many of our Ag Shows across the State for the second year in a row, we moved to execute a comprehensive calendar, including multiple competitions across South East Queensland and measuring days for both Show Horse and Dressage ponies in South East corner and as far as North Queensland. Our year of competition and events was as follows:

- 16 Jan - Show Horse Judges clinic held at Beaudesert RSL with 55 attendees. The clinic resulted in 5 new Judges being placed on the EA Show Horse Judges list and 45 existing refreshing participants. These clinics always receive positive feedback with our presenters covering a wide range of topics across the industry.
- The following day on 17 Jan we held our first measuring day at Park Ridge Pony Club grounds officiated by Chief Measurer Gail Iskra. 35 horses were measured setting them up for a full year of EA competition.
- Our first Hack Show was held at Park Ridge on 7 Feb, with a whopping 75 horses competing across 3 rings with a very comprehensive program. The Jackpot series commenced for 2021 at this show and has gained momentum and popularity since its inception.
- The weekend of 6 - 7 March saw an action-packed offering at the Park Ridge grounds with 35 Youth competitors on Saturday and 55 open competitors on Sunday at the EQ Cup Show. 3 rings were operational throughout the weekend along with additional measuring opportunities for members.
- The interstate 'Southern Cross' championships were held in March 2021 at the prestigious SIEC where Queensland was well represented. Our members were very successful at this very competitive show and we congratulate all those who travelled to attend the event.
- 24 April saw the Annual ANZAC show run with 85 horses competing at this event.
- Our yearly Pryde's EasiFeed Newcomer show was held on 6 June. This show is exclusively for new season horses that have not yet been shown under saddle in the preceding year. 55 young horses competed for the day along with competitors participating in Intermediate and Owner Rider classes. This show is a lovely introduction to competition for the babies held at a quiet and safe venue making for a beautiful day out for all.
- 25 July saw our largest hack show for the year with 109 horses competing across 3 rings and a full program. Competition was fierce and the jackpot classes were once again well supported on the day.
- September saw our most prestigious show of all, the Pryde's EasiFeed EQ HOTY. This Show is historically our largest for the year with over 150 horses participating. Held at the Toowoomba Showgrounds, the two day event covered Open and Childs Show Horses and Show Hunters, showcasing the best our State has to offer over the course of the weekend.

We thank the judges Teena Crutchly, Judy Rankin, Marie Evans, Kylee Chandler and Amy Power (SA) for joining us for the duration of the event. Successfully qualified horses and ponies from this show would have represented Queensland at the 2021 EA Australasian Show Horse & Rider Championships. Unfortunately this National show was postponed due to COVID and is to be held 10-13 March 2022.

- 8 - 9 October – our first ever Adults and Youth training clinic was held at Park Ridge. EA accredited Coaches Mattea Davidson, Gary Lung and Nicole Tough delivered a wonderful two day clinic and we are grateful for their time and commitment to the development of the sport. Off-horse training sessions were also run covering saddle fitting, measuring, ring craft and feeding. Participants enjoyed themselves immensely and we look forward to running another clinic next year.

- The following day on October 10, the committee ran a hack show at the same venue where clinic participants and members could implement their learning from the previous couple of days. 44 horses attended this competition.
- The final competition for the year was held November 21 at Park Ridge where 76 horses made one last ditch effort to get over the line for the year! Run as a very popular T-shirt hack day with no plaiting or jackets, the feedback for this show was very positive and the committee look forward to holding more of these events in 2022.



Running a total of 10 competitions and our adult and youth training clinic, the committee has worked tirelessly to provide all our members opportunity to qualify and compete at the State HOTY.

COVID restrictions eased throughout the year and we were able to continue to enjoy our sport with the support of the Queensland state office staff – Thank you.

DRIVING QUEENSLAND Report

Firstly, Driving Queensland like most other disciplines, was affected by COVID during 2021 and didn't host as many events as we had hoped. However, what we did achieve was very positive and encouraging.

We ran two 'Driving Decoded' weekends in 2021, mid-year at Goombungee, and later in 2021 at Jimboomba, for Drivers and potential drivers, which were very successful. Each weekend used very well-educated schoolmasters and EA accredited coaches to give people lessons in driving and a taste of performance driving. We were very grateful to receive some funding for this from the EQ Sport Development Fund.

Participants were invited to join the Walk Around Tour, covering all sorts of topics including harnessing and putting to, choice of carriages, types of harness, what makes a good Driving horse, Driving Dressage and Challenge Tests (consisting of a shortened Dressage test followed by a series of seven or eight cones pairs in the same arena) and the art/sport of Cones and Obstacle Driving. There was a strong focus on the FEI Training Scale as the basis for horse and driver skills development, as well as on Horse Welfare and Safety at all times.

Driving Queensland committee has also been the most active of state committees in helping to develop a competition pathway for driving within Equestrian Australia. The foundation of this has been in the continuing development of the Challenge tests which began last year with a formidable working group of Mary Seefried, Irene Bakels-Noreen, Wendy Bruszewski and Bob Edwards, have now made their way up the ladder to the EA Driving committee where it looks like they will be ratified and will be part of the new Driving pathway due for release later this year, together with a revised EA Driving Rule Book.

Once a pathway and format for Participant and Competitor events is established, EA affiliated clubs can start running EA events. We hope to see Participant events happening in the first half of 2022, and then Competitor events after that.

We sincerely thank Mary and Irene, as well as Bob and Wendy for their ongoing support and input into the development of the sport of Driving, not just in Queensland but for all Aussie drivers.

- Key priorities/objectives for the next 12 months including 2022 calendar.

We are excited that we may be able to begin Participant and perhaps even Competitor events in the New Year. There is still much work to be done recruiting stewards and officials, training judges and assisting Clubs to be able to successfully run these events.

One of our big aims is to try to involve already successful EA affiliated Clubs in Queensland to collaborate with Drivers and promoters of the sport of Driving to be able to run clinics and competitions. Driving Queensland committee is keen to help, in the form of running Roadshows at different Clubs, or adding some Driving classes at the end of the day at regional Dressage events, or organising clinics with schoolmasters as well as drivers' own horses.

As many of you will be aware, Australian Four-in-hand Driver Boyd Exell continues to reign supreme on the International Driving stage. Queenslanders Tor and Mel Van Den Berge are currently based in the Netherlands and Tor continues to validate his decision to move his family, along with Ross Carbery's two Aussie-bred Dutch Harness mares to Europe.

We should be taking advantage of the fact that Boyd and Tor are at the pointy end of the sport on the world stage, to secure Driving's place as a serious Equine sport in Australia, alongside the much more well-known FEI disciplines of Dressage, Showjumping and Eventing.

We want riders to have a go at Driving, volunteer and train as backstepper/navigators on the carriage, and help us with your expansive knowledge about How to Run EA Competitions. We need to be using the skills of people already very involved with EQ to help us!

Notes to the Financial Statements For the Year Ended 31 December 2021

1. Basis of Preparation

In the opinion of those charged with governance the association is not a reporting entity since there are unlikely to exist users of the financial statements who are not able to command the preparation of reports tailored so as to satisfy specifically all of their information needs. These special purpose financial statements have been prepared to meet the reporting requirements of the *Associations Incorporation Act (QLD) 1981 (as amended by the Associations Incorporation and Other Legislation Amendment Act (QLD) 2007)*.

The financial statements have been prepared in accordance with the recognition and measurement requirements of the Australian Accounting Standards and Accounting Interpretations, and the disclosure requirements of AASB 101 *Presentation of Financial Statements*, AASB 107 *Statement of Cash Flows*, AASB 108 *Accounting Policies, Changes in Accounting Estimates and Errors* and AASB 1054 *Australian Additional Disclosures*.

2. Summary of Significant Accounting Policies

2.1 Cash and Cash Equivalents

Cash and cash equivalents comprises cash on hand, current accounts, deposits at call and short-term investments which are readily convertible to known amounts of cash and which are subject to an insignificant risk of change in value.

2.2 Financial Instruments

On initial recognition, all financial instruments are measured at fair value plus transaction costs (except for instruments measured at fair value through profit or loss where transaction costs are expensed as incurred).

Financial assets are divided into the following categories which are described in detail below:

- loans and receivables; and
- financial assets at fair value through profit or loss.

Financial assets are assigned to the different categories on initial recognition, depending on the characteristics of the instrument and its purpose. A financial instrument's category is relevant to the way it is measured and whether any resulting income and expenses are recognised in profit or loss or in other comprehensive income.

All income and expenses relating to financial assets are recognised in the statement of profit or loss and other comprehensive income in the 'finance income' or 'finance costs' line item respectively.

2. Summary of Significant Accounting Policies

2.2. Financial Instruments

Loans and receivables

Loans and receivables are non-derivative financial assets with fixed or determinable payments that are not quoted in an active market. They arise principally through the provision of goods and services to customers but also incorporate other types of contractual monetary assets.

After initial recognition these are measured at amortised cost using the effective interest method, less provision for impairment. Any change in their value is recognised in profit or loss.

The association's trade and other receivables fall into this category of financial instruments.

In some circumstances, the association renegotiates repayment terms with customers which may lead to changes in the timing of the payments, the association does not necessarily consider the balance to be impaired, however assessment is made on a case-by-case basis.

Financial assets at fair value through profit or loss

Financial assets at fair value through profit or loss include financial assets:

- acquired principally for the purpose of selling in the near future;
- designated by the association to be carried at fair value through profit or loss upon initial recognition; or
- which are derivatives not qualifying for hedge accounting.

Assets included within this category are carried in the statement of financial position at fair value with changes in fair value recognised in finance income or expenses in profit or loss.

Any gain or loss arising from derivative financial instruments is based on changes in fair value, which is determined by direct reference to active market transactions or using a valuation technique where no active market exists.

Impairment of Financial Assets

At the end of the reporting period the association assesses whether there is any objective evidence that a financial asset or group of financial assets is impaired.

Impairment of Financial Assets

Financial assets at amortised cost

If there is objective evidence that an impairment loss on financial assets carried at amortised cost has been incurred, the amount of the loss is measured as the difference between the asset's carrying amount and the present value of the estimated future cash flows discounted at the financial assets original effective interest rate.

Impairment on loans and receivables is reduced through the use of an allowance accounts, all other impairment losses on financial assets at amortised cost are taken directly to the asset.

Subsequent recoveries of amounts previously written off are credited against other expenses in profit or loss.

2.3 Property, Plant and Equipment

Each class of property, plant and equipment is carried at cost less, where applicable, any accumulated depreciation

Property, plant and equipment, excluding freehold land, is depreciated on a reducing balance basis over the assets useful life to the association, commencing when the asset is ready for use. Depreciation rates vary from 10% to 67% and are applied on a diminishing value basis.

The assets' residual values and useful lives are reviewed, and adjusted if appropriate, at the end of each reporting period.

Gains and losses on disposal are determined by comparing proceeds with the carrying amount. These gains or losses are included in the statement of profit or loss and other comprehensive income.

2.4 Goods and Services Tax (GST)

Revenue, expenses and assets are recognised net of the amount of goods and services tax (GST), except where the amount of GST incurred is not recoverable from the Australian Taxation Office (ATO).

Receivables and payable are stated inclusive of GST.

Cash flows in the statement of cash flows are included on a gross basis and the GST component of cash flows arising from investing and financing activities which is recoverable from, or payable to, the taxation authority is classified as operating cash flows.

2.5 Employee Benefits

Provision is made for the association's liability for employee benefits arising from services rendered by employees to the end of the reporting period. Employee benefits that are expected to be wholly settled within one year have been measured at the amounts expected to be paid when the liability is settled.

Employee benefits expected to be settled more than one year after the end of the reporting period have been measured at the present value of the estimated future cash outflows to be made for those benefits. In determining the liability, consideration is given to employee wage increases and the probability that the employee may satisfy vesting requirements.

2. Summary of Significant Accounting Policies

2.6. Revenue and Other Income

Revenue is recognised when the amount of the revenue can be measured reliably, it is probable that economic benefits associated with the transaction will flow to the association and specific criteria relating to the type of revenue as noted below, has been satisfied.

Revenue is measured at the fair value of the consideration received or receivable and is presented net of returns, discounts and rebates.

Grant Revenue

Grant revenue is recognised in the statement of profit or loss and other comprehensive income when the association obtains control of the grant, it is probable that the economic benefits gained from the grant will flow to the entity and the amount of the grant can be measured reliably.

When grant revenue is received whereby the association incurs an obligation to deliver economic value directly back to the contributor, this is considered a reciprocal transaction and the grant revenue is recognised in the statement of financial position as a liability until the service has been delivered to the contributor, otherwise the grant is recognised as income on receipt.

Subscriptions

Membership income is recognised as revenue over the membership period. Unearned membership income in the statement of financial position represents amounts collected for memberships which have not yet been earned.

2.7. Income Tax

The association is exempt from income tax under Division 50 of the *Income Tax Assessment Act 1997*.

3. Critical Accounting Estimates and Judgments

Those charged with governance make estimates and judgements during the preparation of these financial statements regarding assumptions about current and future events affecting transactions and balances.

These estimates and judgements are based on the best information available at the time of preparing the financial statements, however as additional information is known then the actual results may differ from the estimates.

The significant estimates and judgements made have been described below.

Key Estimates - Receivables

The receivables at reporting date have been reviewed to determine whether there is any objective evidence that any of the receivables are impaired. An impairment provision is included for any receivable where the entire balance is not considered collectible. The impairment provision is based on the best information at the reporting date.

Key Estimates - Provisions

As described in the accounting policies, provisions are measured at management's best estimate of the expenditure required to settle the obligation at the end of the reporting period. These estimates are made taking into account a range of possible outcomes and will vary as further information is obtained.
