## JUDGING DISCREPANCIES REPORT FORM 2020

- for each horse in the class where there is a discrepancy
- in full (please answer all questions comprehensively)
- by the Chief Judge of the relevant competition & in conjunction with the respective judges with discrepancies (even if the C judge does not have the discrepancy)
- when there is a discrepancy between individual judges of 8% or greater in National Classes &
- when there is a discrepancy of 5% or greater in FEI Level Classes
- ideally on the same day, at the event
- and a copy to be forwarded within 7 days of the event
- where possible with a copy of the judges test sheets attached

### Guide to completing the form;

**Event:** name of the dressage event where the judging occurred

**Location:** suburb will suffice

**Date:** dd/mm/yyyy

**Rider Name:** full name of the rider

**Class:** EA test number/FEI specific test

**Number in class:** total number of competitors in the class

**Horses Name:** EA registered name of the horse

**Bridle Number:** EA bridle number of the horse

**Judge at C:** name of the chief judge @ C

**%:** the final score xx.xxx%

**Ranking:** the final ranking for that judge ie 1/8 (1<sup>st</sup> of 8 horses)
