- Points allocated 1<sup>st</sup> 7 points, 2<sup>nd</sup> 5 points, 3<sup>rd</sup> 4points, 4<sup>th</sup> 3 points, 5<sup>th</sup> 2 points, 6<sup>th</sup> 1 point
- If there is an equality of points at the end of the series the rider with the most consistent high placings throughout the series will become the series winner
- To be eligible to be the winner of the title you must be a current financial member of Equestrian Queensland

- 1. OTT/Thoroughbred (Off the Record) Registered Studbook Thoroughbred, Raced, Trialed, unraced. Do not have to be EA registered (Competition 80-100 cm)
- OTT/Thoroughbred (On the Record) Registered Studbook Thoroughbred that have Raced, Trialed, unraced that are EA Registered (competition will be 1.05 cm - 120 cm)

#### **RULES**

- 1. Riders must be EA or PC current 2021 Financial members.
- 2. Studbook/Life Numbers to check validation.
- 3. Both Off the Record and On the Record have raced trialed or unraced and can be any age.
- 4. Horses competing in On the Record class must have EA registration.
- 5. Horse/rider combination can move between the heights but not on the same day.
- 6. To be eligible, the Horse and Rider combination must compete in the two-part challenge with first round Friday and second round Saturday.
- 7. For On the Record combinations the highest points gained will be taken from either classes 2,3 or 4 Friday then from classes 7 or 8 on Saturday and added together. The combination with the highest total points from the two days will take the total prize of \$400 plus the rug sponsored by Qld Racing.
- 8. For Off the Record combinations, the highest points gained will be taken from either classes 12a, 12b or 13 on Friday and then from classes 17 or 18 on Saturday and added together. 
